28 ISSUES PAPER – PLANNING APPLICATION REF. 14/00465/FULM FOR RESIDENTIAL DEVELOPMENT OF 157 DWELLINGS, TOGETHER WITH ASSOCIATED ACCESS, PARKING, PUBLIC OPEN SPACE AND LANDSCAPING LAND AT LIMBURG AVENUE, LICHFIELD:

Consideration was given to an Issues Paper relating to the proposed development.

RESOLVED: That the following issues, in addition to the summary

of key issues listed in Appendix 1 be addressed in the assessment of the above planning application when it comes before Planning Committee for determination:

- Need to recognise this as a gateway site into the City and therefore high quality design is important.
- What contributions would be made towards completing the rest of the Lichfield Southern Bypass, to ensure its delivery?
- Note the proposal if for 2 isolated parcels of land not linked directly to Darwin Park, as 2 accesses proposed off the Bypass.
- Issues regarding impact on allocated recreation land needs addressing.
- Need to carefully consider landscape and links thereto.
- Issues with regard to direct access from Lichfield Bypass need to be addressed-should this occur?
- Clarity on how close new dwellings would be to existing 2.5/3 storey dwellings on Darwin Park needed and whether overlooking/loss of amenity would be caused to the residents of this proposed development.
- Amenity of existing residents.
- · Policy issues.
- Should look at Larks Rise for design cues, as this presents an example of good design.
