264 HAMMERWICH – 14/01025/COU – RETENTION OF EXISTING CEMETERY BUILDING AND CHANGE OF USE TO MAUSOLEUM AND CREATION OF OVERFLOW PARKING AT WALSALL BURIAL PARK, BURNTWOOD WAY, BURNTWOOD FOR MIDLANDS FUNERAL DIRECTORS LTD

RESOLVED: That planning permission be refused for the following reasons:-

The site lies within the Green Belt where new development is inappropriate unless it meets one of the exceptional circumstances. The applicant has not provided very special circumstances, including a proven need for a mausoleum in this location, to outweigh the harm caused to the Green Belt and the development therefore constitutes inappropriate development. The development is therefore contrary to Policy NR2 of the Lichfield District Local Plan Strategy (2015) and the National Planning Policy Framework.

The development does not provide adequate parking within the site boundary thereby increasing the likelihood of people parking on the public highway, to the detriment of the safety of users of the highway contrary to Policy ST2 of the Lichfield District Local

Plan Strategy (2015).

The site lies adjacent to the local school and, due to noise and general disturbance within school grounds, will not offer peaceful surroundings leading to the likelihood of complaints against the school contrary to Policy BE1 of the Lichfield District Local Plan Strategy (2015).

Note to applicant:

The Local Planning Authority has worked with the applicant but it is considered that the proposal does not conform to the core planning principles of the NPPF.
