Dear Dave / Colin,

Apologies for the delay in responding to your emails on this; I realise how important this is and wanted to make sure I have accurate information to share with you and have been waiting for that to come to me. I now have the following information:

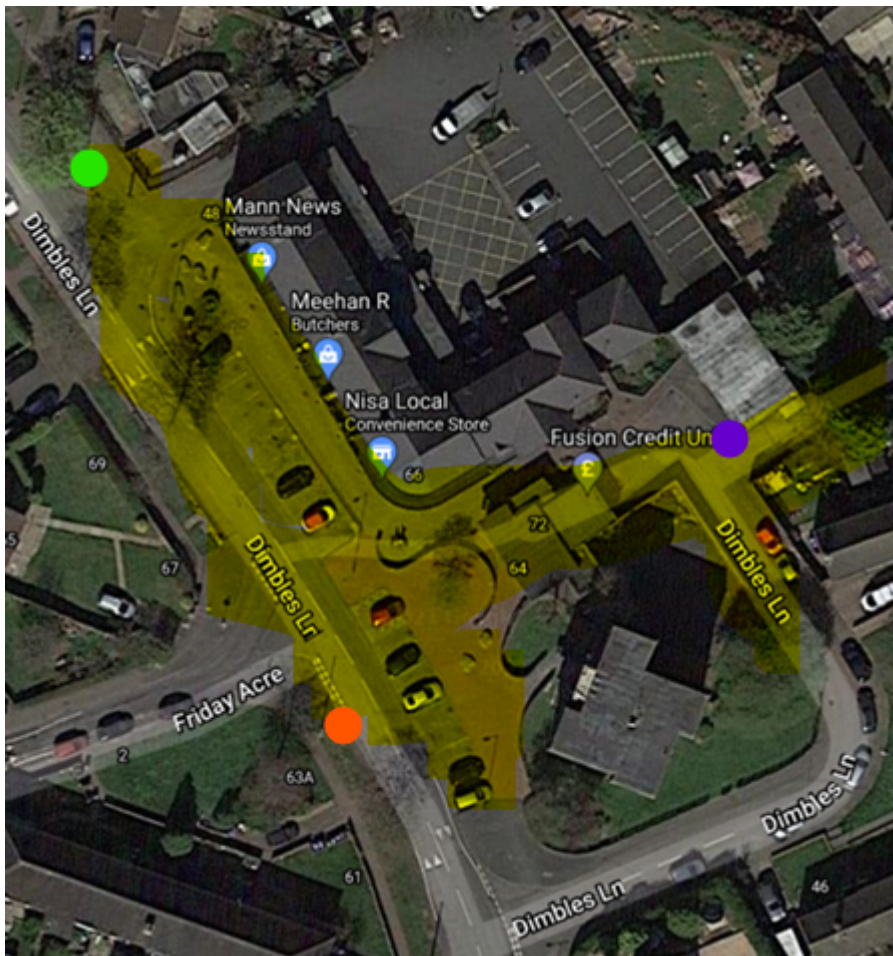
1. The data link between the Dimbles and the CCTV control room **was not in place** in time before the press release went out.
2. The intent was for the camera's to be linked from launch.
3. Clearly, this should have been checked and the press release should have been more accurate / changed to state that 'The cameras WILL BE monitored remotely 24 hours a day, seven days a week in a control room in Lichfield city centre'.
4. I have asked for an explanation as to what the delay is and when it will now be connected. (@[Gemma Holder](#) – please can you share that information with everyone on this email as soon as we have it from Nathan?).
5. While the cameras were not live monitored, the cameras are still fully operational and are being recorded 24/7 with extensive coverage around the Dimbles shopping area (see picture below).
6. We have already had a request from the Police to review the footage and are working with them and will provide the relevant footage to see if there's any evidential material that they can use.

**What are our camera's filming?**

We have 3 camera locations and they have been positioned to see the Dimbles shops, Laundrette and alley way, parking spaces and Dimbles Lane Road as highlighted below:

- Camera 1 Junction of Dimbles Lane and Friday Acre (Orange dot)
- Camera 2 Entrance to Dimbles Lane shops (Green dot)
- Camera 3 Dimbles Lane by Laundrette (Purple dot)

Assuming the ASB was carried out in the immediate vicinity or people are seen in this area at the times and dates stated then the Police will hopefully be able to use the intelligence to identify those involved.



Cllrs Cox & Pullen copied in following your questions to me this morning about the same.

Dear Simon,

Apologies for not getting back to you about this on Friday. I really must say that I am very disappointed that the cameras are still not operating in the way that we were told they would be, seven months after the first cameras were installed. I cannot think that anyone would think that this is an acceptable position to find ourselves in, and that such an extended period of time has elapsed with no information coming to members and no remedy is a very poor reflection of the quality assurance that we are undertaking as an organisation.

The situation absolutely must be rectified as a matter of urgency. We have already been waiting since August for the installation to be completed, and I would hope that we would have a short timescale for the completion of these works that will be shared with us this week. The data link is essential to the proper functioning of the cameras if they are to act as a proper deterrent - one of the reasons for needing them installed was so that problems could be picked up and reported to the police in real time. The events of New Year's Eve are a very good example of where the information from the cameras could have been picked up and the Police informed as it was occurring. If this were the case at the start of the Year it is entirely possible that some of the property damage which has happened could have prevented by a prompt intervention from the camera team and then the police.
