20/01439/REMM – Land off Halifax Avenue, Fradley Park, Fradley Reserved matters application for the erection of a new two phased 2FE primary school with MUGA, football pitch, external landscaping, car parking and associated facilities FOR: Staffordshire County Council

Staffordshire County Council Consultation (L.20/03/867 M)

Our ref: 20/00722/SCC – Land South of the A513, Orgreave, Alrewas, Burton Upon Trent, Staffordshire

Proposed sand and gravel extraction, the erection of associated plant and infrastructure and creation of new access, in order to supply the HS2 project with ready mix concrete with exportation of surplus sand and gravel
