## 1. Executive Summary

- 1.1 Dual Stream recycling will be introduced in spring 2022 in both Lichfield and Tamworth. Cabinet and Council have agreed both the policy and the financial implications of this service change.
- 1.2 Subsequent to the update of the MTFS agreed by Council 12 October 2021, the procurement process for the kerbside recycling bags has been completed. This has identified that the costs of the bags will be higher than initially projected reflecting the tightening of international market conditions.
- 1.3 Given the need to act expediently to deliver the service change in spring 2022, a transfer of resources from the Joint Waste Service's reserve to the capital allocation for the dual-stream project was agreed by Cabinet 9 November 2021.

## 2. Recommendations

- 2.1 That Council update the Medium Term Financial Strategy based on the additional financial implications of Dual Stream Recycling, specifically:
  - to increase the Capital Programme in the Medium Term Financial Strategy for the purchase of bags/bins in 2021/22 by £100k from £229k to £329k. This will be funded by a contribution of £41,000 from Tamworth and the Council's share of £59,000, both from the Joint Waste Service's Property Growth Reserve.

## 3. Background

- 3.1 The introduction of Dual Stream Recycling in 2022 will require the majority of Lichfield's residents to present their card and paper for recycling in a bag rather than the existing blue bin. This approach is also being taken by three other Staffordshire authorities who are making this change in 2022. For operational reasons, a small number of rural properties in Lichfield will be given an additional bin for the paper and card rather than a bag.
- 3.2 Until quite recently the cost of purchasing both bags and bins had been stable. The Staffordshire authorities modelled financial costs earlier this year, based on purchasing these items for prices in line with those paid by Newcastle-under-Lyme and Stafford Borough Councils when they both introduced Dual Stream collections last year. However all the potential suppliers have recently raised their prices significantly in a response to a tightening of international market conditions. Initial pre-procurement market engagement suggested a £71k increase in the cost of the number bags required by the Joint

Waste Service. The actual procurement process has identified the actual cost increase to be just under £25k.

3.3 Similar and continuing price rises are being seen across a range of commodities, especially where there is a reliance on imports. For this reason, it is proposed to increase the capital allocation for the dual-stream transition by £100k to provide some additional headroom to ensure that the project can be delivered in spring 2022.
