Please describe briefly the nature of the proposed variation (please read guidance note 2)

The premises has the benefit of Premises Licence number 05/00804/LAPREV and unlicensed external areas currently used for the consumption of food and drinks/alcohol.

1) License external servery

The variation principally seeks to license a particular external area of the premises as identified on the plan deposited with the application, being drawing 12.21/91048/SP, principally to authorise the sale of alcohol from an external servery structure until no later than 22.00 daily.

For the avoidance of doubt, all existing licensable activities extend to the internal areas outlined in red on the deposited plan. The external areas edged red will be licensed under this application for the sale of alcohol only.

The sale of alcohol in external areas has taken place numerous times over several years as authorised by Temporary Event Notices. Taking this into consideration, it is not anticipated that the application will have an adverse impact on the licensing objectives. No amendments are proposed to the general method of operation of the premises or the trading hours for licensable activities and accordingly Boxes A – I have not been completed. Box J has been completed with regard to the proposed external use.

In addition, the applicant agrees to the following condition being placed on the licence should the variation be granted as requested:

- *Sale alcohol will not take place from the external bar servery after 22.00.*

2) Deletion of PEL conditions

The variation seeks to delete numerous conditions on the licence carried across from the previous licensing regime as these are now outdated or are adequately covered by other legislation.

The conditions to be deleted are principally all those on the former Public Entertainment Licence and the embedded restriction under the Children & Young Persons Act 1933. An indicative document has been filed with this application illustrating the conditions to be deleted struck through in red.

None of these deletions are intended to be controversial and it is not considered that their deletion will adversely affect the four licensing objectives. The deletions are principally an attempt to modernise the Premises Licence and provide greater clarity as to the obligations of the premises licence holder.

3) Occupancy condition

The occupancy condition is located at Annex 2 condition 6, under the heading '*prevention of crime and disorder*'.

This condition is to be amended to set the occupancy in line with the Fire Risk Assessment. The amended condition is to state:

- *"The occupancy level of the premises is fixed in accordance with the Fire Risk Assessment from time to time".*

It is not considered that this proposal will adversely affect the four licensing objectives as the premises will continue to operate safe occupancy levels in accordance with any Fire Risk Assessment. Further, Article 43 Regulatory Reform (Fire Safety) Order 2005 makes such conditions placed on Premises Licences redundant.

Overall, the proposals have been discussed with the Police and Environmental Health/Protection prior to submission. As neither indicated any issues with the proposals then it is not anticipated that they will adversely affect the four licensing objectives and the operating schedule has been completed on that basis.

Notes for Guidance

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates. If you wish to make that type of change to the premises licence, you should make a new premises licence application under section 17 of the Licensing Act 2003.

1. You do not have to pay a fee if the only purpose of the variation for which you are applying is to avoid becoming liable for the late night levy
2. Describe the premises. For example, the type of premises, its general situation and layout and any other information which could be relevant to the licensing objectives. Where your application includes off-supplies of alcohol and you intend to provide a place of consumption of these off-supplies of alcohol, you must include a description of where the place will be and its proximity to the premises.

 - Plays: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500.
 - Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.

- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
 - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
 - Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
