Annex 1 - Mandatory conditions

This Licence is subject to the Mandatory Conditions set in Section19 Licensing Act 2003 reproduced below:

Mandatory Conditions - Supply of Alcohol

- (1) No supply of alcohol may be made under the Premises Licence
- (a) At a time when there is no Designated Premises Supervisor in respect of the Premises Licence, or
- (b) At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- (2) Every supply of alcohol under the Premises Licence must be made or authorised by a person who holds a Personal Licence

Licensing Act 2003 (Mandatory Conditions) Order 2014

- (1) A relevant person shall ensure that no alcoholis sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- (2) For the purposes of the condition set out in paragraph 1-
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
 - (b) "permitted" price is the price found by applying the formula P=D+(DxV)

where-

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcoholas if the value added tax were charged on the date of the sale or supply of the alcohol;
 - (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
 - (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- (3) Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on aday ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

Licensing Act 2003 (Mandatory Conditions)(Amendment) Order 2014

- 1 (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
- (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective;
- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
- (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can be reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner;
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person in unable to drink without assistance by reason of disability).
- The responsible person must ensure that free potable water is provided on request to customers where it is reasonable available.
- 3 (1) The premises licence holder or club premises certificate holder must ensure than an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either-
- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 4 The responsible person must ensure that-
- (a) Where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
- (i) Beer or cider: ½ pint;
- (ii) Gin, rum, vodka or whisky: 25ml or 35ml; and
- (iii) Still wine in a glass: 125 ml;
- (b) These measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
- (c) Where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Mandatory condition: Door supervision

- 1. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must:
- (a) Be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2003: or
 - (b) Be entitled to carry out that activity by virtue of section 4 of the Act.

- 2. But nothing in subsection 1. Requires such a condition to be imposed:
- (a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c21)(premises with premises licences authorising plays or films); or
 - (b) in respect of premises in relation to:
- (i) Any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising films or under a gaming licence, or
- (ii) Any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act.
- 3. For the purpose of this section:
- (a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and, which is licensable conduct for the purposes of that Act,
- (b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

Mandatory condition: exhibition of films

- (1) Where a premises licence authorises the exhibition of films, the licence must include a condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.
- (2) Where the film classification body is specified in the licence, unless subsection (3)(b)applies, admission of children must be restricted in accordance with any recommendation made by that body.
- (3) Where -
 - (a) the film classification body is not specified in the licence, or
- (b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question,

admission of children must be restricted in accordance with any recommendation made by this licensing authority.

(4) In this section -

"children" means persons aged under 18; and
"film classification body" means the person or persons designated as the authority under section 4 of the Video
Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification)

Conditions carried forward upon conversion of Public Entertainment Licence [Local Government (Miscellaneous Provisions) Act 1982] - (Appendix A)

- 1. The licensed premises shall only be used for the Entertainment specified on the attached licence.
- 2. The licensed premises shall not be used for any public entertainment on a Christmas Day.
- 3. The licensee shall comply with the recommendations of the Fire Officer as detailed in appendix 'B' below and additionally with any recommendation of the Police Authority.
- 4. No material alterations, refurbishment or additions shall be made to any part of the premises without the prior approval in writing of the Licensing Authority.

- 5. Authorised officers of the Local and Fire Authorities and Police Officers shall have free access to the licensed premises at all reasonable times.
- 6. A copy of this licence shall be displayed and maintained in some conspicuous place in the foyer or the main public entrance area of the licensed premises.
- 7. The licensee or some responsible person nominated by him in writing not being a person under 21 years of age, shall be in charge of and present in the licensed premises at all times when the public are in the licensed premises and the licensee shall ensure that such nominated person is supplied with a copy of this licence and is aware of all the terms and conditions to which the licence is subject.
- 8. If the premises are to be used for any of the licensed functions other than under the direct control and supervision of the licensee, the licensee must provide the person responsible for the function with a copy of these and any other conditions to which the Licensee is subject.
- 9. In the event of the premises being used in a manner as outlined in Condition 8, the Licensee is required to specify the name and address of the person responsible for the function in the notice required by Condition 18 of the Fire Safety Conditions (See Appendix `B')
- 10. (a) The licensee or the person in charge shall to the best of his ability maintain and keep good order and decent behaviour on the licensed premises.
 - (b) The licensee shall not allow any lewd, obscene or indecent performances to take place on the licensed premises, or allow any indecent poster, advertisement, film, photograph or programme to be displayed or shown therein.
 - (c) The licensee shall keep and maintain good order and decent behaviour in the licensed premises during all times that the licensed premises are kept open or used under this licence, and shall not permit drunkenness or any disorderly conduct upon the licensed premises, nor permit or suffer any betting, unlawful gambling or any unlawful games therein.
- 11. The licensee shall:
 - (a) take all reasonable precautions for the safety of the public, performers or employees on the premises;
 - (b) ensure that the licensed premises and any fittings, stairways, notices, lavatories and seating are maintained in good order and a safe condition.
- 12. Adequate and separate sanitary conveniences shall be provided for persons of both sexes.
- 13. The licensee or person in charge of the premises shall ensure that any noise emanating from the premises is such as not to cause annoyance to the residents in the locality.
- 14. No person shall give at the licensed premises (otherwise than as provided by Section 5 of the Hypnotism Act, 1952) any exhibition, demonstration or performance of hypnotism, mesmerism or any similar act or process which produces or is intended to produce in any other person any form of induced sleep or trance in which the susceptibility of the mind of that person to suggestion or direction is increased or is intended to be increased, unless such exhibitions etc. is:-
 - (a) specifically authorised, in writing, by the licensing authority and;
 - (b) any member of the audience who takes part in the activity does so knowingly and;
- (c) the activity is carried out in such a manner so as not to degrade or endanger any person taking part or to endanger any other person in attendance, and;
- (d) the act shall not include rigidity experiments, and;
- (e) the hypnotist must remove all post hypnotic suggestions from all persons before those persons leave the premises.

- 15. The attention of the licensee is drawn to the provisions of the Building Regulations 1991 (as amended) Part M insomuch that where appropriate, facilities and adaptations including staffing arrangements should be made to enable disabled persons to attend entertainments at the licensed premises.
- 16. The licensed premises shall be defined as being the premises demarcated on the attached plan to the application and the entertainments area shall be those parts of the licensed premises coloured or shaded on the plan.
- 17. The public parts of the licensed premises shall be kept properly and sufficiently ventilated and heated to the satisfaction of the Licensing Authority.
- 18. If the Licensing Authority deem it necessary for the protection of the safety of the public using or entering the licensed premises, the Licensing Authority or any person authorised by them may impose any term condition or restriction herein contained and the licensee shall immediately comply with such terms, conditions and restrictions.
- 19. The electrical circuits used for instruments, audio equipment and other equipment shall be provided with a Residual Current Device.
- 20. The licensee shall furnish to the Licensing Authority a certificate signed by a suitably qualified person stating that the ceiling, including any lights and fittings attached thereto, above the area of the premises which is subject to this licence is structurally sound and in a safe condition. Such a certificate shall only be issued after a full inspection of the relevant area has been made by the person whose signature appears on the document and shall only be valid for a period of five years from the date of the signature.
- 21. All persons engaged, used or employed on licensed premises to vet, regulate and control persons entering the premises or engaged, used or employed to ensure the maintenance of good order, public

safety and internal security shall be required to be licensed with the Security Industry Authority.

- 22. There is to be displayed at the entrance to the premises a clearly visible notice advising all patrons that they are liable to be searched before being allowed entry.
- 23. The Licensee shall take all reasonable precautions to prevent disturbance being caused to local residents by persons frequenting the licensed premises and in particular a notice of suitable size and wording must be displayed in a prominent position adjacent to all the public exits advising patrons leaving the licensed premises late at night to do so quietly so as not to cause any disturbance to local inhabitants.
- 24. No noise generated by any entertainment at the licensed premises shall be for such periods of time or such levels of intensity so as to render liable to damage the hearing of persons attending the entertainments.
- 25. Where car parking facilities are provided within the curtilage of the licensed premises or otherwise under the direct control of ownership of the Licensee the Licensee shall be responsible for ensuring adequate control over persons and vehicles using those parking facilities.
- 26. The use of laser and other special effects likely to have a detrimental effect upon persons attending the entertainment shall not be used without the prior consent of the Licensing authority and shall be subject to any specific conditions attached to any such consent.

Conditions and regulations carried forward in respect of premises licensed for public entertainment and stage plays and private entertainment upon conversion of Public Entertainment Licence - (Appendix B)

SAFETY FROM FIRE

MEANS OF ESCAPE:

(1) Adequate means of escape in case of fire shall be provided and maintained to the satisfaction of the licensing Authority on the recommendations of the Chief Fire Officer.

DOORS:

- (2) Every door for use by patrons which permits egress from either the hall or other parts of the premises shall:-
 - (a) Open outwards, unless the licensing authority shall have been satisfied that this is impracticable or unreasonable in the circumstances of the case; and
 - (b) Open easily and fully in such a manner that the door when open does not restrict egress.
 - (c) Any such doors which do not open outwards must be securely retained in the open position at all times when the premises are in use.
 - (d) Doors fitted with 'panic bolts' must have a notice "PUSH BAR TO OPEN" in block letters at least 50mm in height and of proportionate width conspicuously displayed immediately above the horizontal operating bar.

ESCAPE ROUTES:

(3) All doorways, gangways, corridors, staircases and external passageways for use in the licensed premises shall be kept clear of any obstruction at all times when the premises are in use.

SEATING: (all functions):

(4) (a) Seating, tables and chairs and other furniture and fittings shall be so arranged as to allow free and ready access to the gangways leading to the exits.

ACCOMMODATION:

(5) (a) The maximum number of persons to be accommodated in the premises at any one time must not exceed :-

Lounge - 100 persons

Public Bar - 35 persons

Marquee in field at rear - Variable occupancy depending on size (installer to provide certification)

(b)The maximum number of persons permitted to be in any entertainment area at any time shall be as follows:- n/a

ATTENDANTS:

- (6) (a) At all times when a function is in progress, the number of attendants on duty to assist persons entering and leaving the premises shall be as follows:-
 - (i) SEATED AUDIENCES:

Not less than one for every hundred or part of one hundred persons present.

- (ii) OTHER FUNCTIONS:
 - Not less than two for attendances of up to two hundred, plus one additional attendant for each additional hundred, or part of one hundred, persons present.
- (b) For the purposes of the foregoing paragraph, persons solely engaged in the sale of chocolates or refreshments and persons employed in payboxes, restaurants etc. shall not be regarded as attendants or stewards.
- (c) Where children form the majority of the persons attending, the licensing authority on the recommendation of the Chief Fire Officer, may require the number of attendants to be increased according to the circumstances of the case.
 - (d) The licensee shall ensure that each official attendant is aware of the method of operating the fire extinguishers provided in the premises and in the action to be taken in the event of fire, including evacuation of the premises and the method of calling the fire brigade.

FIRE ROUTINE:

(7) A procedure approved by the licensing authority, on the recommendation of the Chief Fire Officer, detailing the action to be taken by the attendants in the event of fire shall be devised and posted in the form of a notice in such a way that it can be read by the attendants, but not by patrons.

TELEPHONES:

(8) If an exchange telephone is available in the building, a notice must be provided and prominently displayed in the appropriate part of the premises, stating the location of

- this telephone. Additionally, a notice must be provided adjacent to the telephone, giving instructions as to the method of calling the Emergency Services.
- (b) A notice must be provided and predominantly displayed in the appropriate part of the premises giving the location of the nearest public telephone.

LIGHTING:

(9) In addition to the primary lighting, emergency lighting as defined by British Standard 5266: Part 1:1988 sufficient to enable the public to see their way out of the premises in the event of

failure of the normal lighting should be provided in the premises to include all escape routes both internal and external.

The emergency lighting should be wired into the appropriate mains lighting sub-circuit in order that the units will operate upon the failure of the primary lighting within the same areas.

It is recommended that the isolation points for all lighting circuits are clearly indicated for ease of testing and maintenance.

EXIT SIGNS:

- (10) (a) Every exit for use by the public in leaving the hall shall be clearly indicated by a suitable exit sign complying with the Health and Safety (Safety Signs and Signals) Regulations 1996. The dimensions of the sign will be determined by the Fire Authority. The sign shall be illuminated to conform with condition 9 above.
 - (b) Directional arrows to the same details and dimensions as above shall accompany the exit signs, except where the signs mark the actual exit. Whenever possible, the signs shall be placed above the doors to which they relate. Where this is not practicable, they should be placed as near as possible to such doors to clearly indicate the exit route.

FIRE EXTINGUISHERS:

(11) The premises shall be provided with a sufficient number of suitable fire extinguishers which shall be so placed as to be readily available for use at all times when the premises are in use.

SCENERY AND DRAPES:

(12) All scenery, stage curtains and similar hangings and decorations, shall be of such material or so maintained, that they will not readily catch fire.

FURNITURE, FITTINGS AND CARPETS

(13) All furniture, fittings and carpets shall be of such material or so maintained that they will not readily catch fire.

FLAMMABLE MATERIALS:

- (14) (a) Real flame, explosive, cotton wool, or highly flammable materials shall not be used or kept on the premises when patrons are present unless the prior written consent of the licensing authority, on the recommendation of the Chief Fire Officer, has been obtained.
- (b) Smoking shall not be permitted in the stage area, that is to say, on the stage or in the wings, except where it is a necessary incident of the performance. "No Smoking" notices shall be displayed in the wings.

WALL & CEILING LININGS:

(15) The linings of walls, partitions and ceilings in areas used by patrons, except as otherwise stated, are accepted by the licensing Authority, on the recommendation of the Chief Fire Officer as being of the standard detailed below. Such linings shall be maintained to this standard, as follows:-

The linings of ceilings, walls and partitions are accepted by the Fire Authority as being of the following minimum standard, except where otherwise indicated on the plans: -

- (a) In escape routes and circulation spaces Class 'O' as defined by Approved Document B of the Building Regulations 1991.
- (b) In small rooms not exceeding 4m2 and as part of the walls of other rooms if the total area of those parts does not exceed an area equivalent to one half of the floor area subject to a maximum of 20m2 Class 3 as defined by British Standard 476: Part 7
- (c) In all other rooms Class 1 as defined by British Standard 476: Part 7.

EXAMPLES

- Class O Brickwork, blockwork, concrete, plasterboard, ceramic tiles, plaster finishes (including rendering on wood or metal lathes), woodwool slabs, thin vinyl and paper covering on inorganic surface (other than heavy flock wallpapers) and certain thermosetting plastics.
- Class 1 Timber, hardboard, particleboard (chipboard), heavy flock wallpapers, thermosetting plastics, that have been flame retardant treated.
- Class 3 Timber, hardboard, blockboard, particleboard (chipboard), heavy flock wallpapers, thermosetting plastics and thermoplastics (expanded polystyrene wall and ceiling linings).

HEATING:

(16) Every heating appliance used in the premises shall be installed and maintained in a safe manner. All open fires and heating appliances shall be adequately guarded.

ELECTRICAL INSTALLATIONS:

- (17) (a) All electrical wiring and fittings shall be installed and maintained to the satisfaction of the licensing authority.
- (b) If required by the licensing authority, the licensee shall obtain and submit a report issued by a qualified electrician in respect of any part or the whole of the electrical installation.
- (c) A sensitive earth leakage protection system (residual current circuit breaker) having a rated residual operating current of not exceeding 30 milli-amps shall be installed and maintained as part of the fixed wiring installation supplying the stage area, or any electrical socket used for the supply of electricity to amplifiers, musical instruments or any similar equipment.

GENERAL:

(18) Where an annual licence is in force, except in the case of premises in constant use for entertainment, at least fourteen days prior to the date of any function, the licensee shall give to the Chief Fire Officer at Fire Brigade Headquarters, Pirehill, Stone, Staffs, ST15 OB notice in writing of the function and shall state in the notice the date(s) of the proposed function(s).

Embedded restriction Children and Young Persons Act 1933 Section 12 (providing for the Safety of Children at Entertainments - see enclosure)

Where the number of children attending the entertainment exceeds 100 the licensee shall ensure that the provisions of Section 12 of the Children & Young Persons Act 1933 are complied with.

Annex 2 – Conditions consistent with the Operating Schedule

The prevention of crime and disorder

- 1. Any person exercising a security activity will be employed at the premises at the discretion of the Designated Premises Supervisor/holder of the premises licence.
- 2. Any person as defined in condition 1 above will clearly display his name badge at all times whilston duty.
- 3. No customers apparently carrying open bottles upon entry shall be admitted to the premises at any times the premises are open to the public.
- 4. Where CCTV is installed with recording facilities the recordings shall be retained for 30 days and made available within a reasonable time to the Police on request.
- 5. Alcoholic and other drinks may not be removed from the premises in open containers save for consumption in any external area provided for that purpose.
- 6. The maximum occupancy will be restricted to 100 persons for the lounge, 35 persons for the public bar and a variable occupancy for the Marquee as per the converted Public Entertainment licence.

The prevention of public nuisance

- 1. Where appropriate, prominent, clear and legible notices shall be displayed at all exits requesting the public respect the needs of local residents and to leave the premises and area quietly.
- 2. Noise or vibration shall not emanate from the premises so as to cause a nuisance to nearby properties.


The protection of children from harm

1. Children under the age of 16 shall not be permitted to enter the premises after 2100 hours.

GUIDANCE NOTES

DUTIES IN RESPECT OF A PREMISES LICENCE OR CLUB PREMISES CERTIFICATE

Display of the Premises Licence Summary

The holder of the premises licence must ensure that:-

- The summary of the Licence or a certified copy of that summary, and
- A notice specifying the position held at the premises by any person nominated, are prominently displayed at the premises.
- The holder of a premises licence commits an offence if he fails, without reasonable cause to comply with this requirement
- A constable or an authorised person may require the person who is required to have the Premises Licence (or certified copy of it) in his custody or under his control to produce the Licence (or such copy) for examination.
- A person commits an offence if he fails, without reasonable excuse, to produce a Premises Licence ora certified copy of a Premises Licence.

Safe keeping of the Premises Licence

Whenever premises are being used under the authority of a Premises Licence or Club Premises Certificate for one or more authorised licensable activities, the holder must ensure that the licence/certificate, or a certified copy of it is kept at the premises, in the custody or under the control of:-

- The holder of the Licence or,
- A person who works at the premises and whom the holder of the licence has nominated in writing

Theft, loss of Premises Licence or Summary

Where a Premises Licence or summary is lost, stolen, damaged or destroyed, the holder of the licence may apply to the relevant licensing authority, namely Lichfield District Council for a copy of the licence or summary. The licensing authority will issue the licence holder with a certified copy of the licence. The fee payable is £10.50.

Period of Validity

A Premises Licence has effect until such time as:-

• It is revoked, or if it specifies that it has effect for a limited period, that period expires.

Surrender of a Premises Licence

- Where the holder of a Premises Licence wishes to surrender his licence he may give the relevant licensing authority, namely Lichfield District Council, a notice to that effect.
- The notice must be accompanied by the premises licence, or if that is not practicable, a statement of the reasons for the failure to provide the licence.
- Where a notice of surrender is given, the premises licence lapses on receipt of the notice but the authority namely Lichfield District Council.

Death, incapacity, insolvency etc of a licence holder

A premises licence lapses if the holder of the licence:-

- Dies
- Becomes mentally incapable (within the meaning of section 13(1) of the Enduring Powers of Attorney Act 1985
- Becomes insolvent
- Is dissolved


