1. Executive Summary

1.1 To consider an application received from Mr Will Baggott, Barratt, West Midlands for the diversion of public footpath No. 42 (part) in the Parish of Fradley and Streethay. The application is to be considered under the Town and Country Planning Act, Section 257.

2. Recommendations

2.1 To approve the proposed diversion of Public Footpath No. 42 (part) in the Parish of Fradley and Streethay as set out in Appendix A to allow for necessary development.

3. Background

- 3.1 An application has been submitted under the Town and Country Planning Act 1990 from Mr Will Baggott, Barratt, West Midlands for the proposed diversion of Public Footpath No. 42 in the Parish of Fradley and Streethay.
- 3.2 The application has been made in connection with planning application 19/00555/REMM for the construction of 250 new dwellings and associated infrastructure, provision of football pitches and changing facility.
