Executive Summary 1.

1.1 To seek members decision regarding the confirmation of Tree Preservation Order no 2023/00481/TPO

2. Recommendations

2.1 That the Committee confirm the Tree Preservation Order without modifications.

Background 3.

3.1 A tree preservation order was made on the 21st of March 2023 in respect of trees at 'Wyevern', Bellamour Way, Colton, WS15 3LN:

The tree preservation order was made in response to a section 211 (Conservation Area notification) for the felling of two Weeping Willow trees. The trees are visible and prominent from Bellamour Way and surrounding residential properties. The trees provide amenity to this area of Colton and are considered to have considerable safe, useful life expectancy

- 3.2 One objection to the order was received and raised a number of points. Correspondence was entered into regarding the objection and a site visit was carried out on the 5th of July 2023. However, the objection has not been negotiated away.
- 3.3 The objections are detailed below and are dealt with in context for ease of reference:

Summary of objections:

- a. The TPO omits any reference to the reasons given for felling in the Section 211 notice
- b. Damage to the driveway
- c. Raising of the floor level of the garage
- d. Concerns regarding the trees leaning
- e. Proximity to property

Objection a.

The TPO omits any reference to the reasons given for felling in the Section 211 notice

Response to objection a.

When making a TPO, a Local Authority is obliged to set out their reasons for making the order. This is communicated within the regulation 5 notice (in the form of a letter) that accompanies the TPO. In this instance the reasons given were:

A recent S211 Notice has detailed the removal of the trees within this TPO. The trees are visible and prominent from Bellamour Way and surrounding residential properties. The trees provide amenity to this area of Colton and are considered to have considerable safe, useful life expectancy.

The reasons for making the order include that a S211 notice was submitted in respect of the removal of the trees as this is relevant to the Council's making of the order. However, the reasons for the initial submission of the notice are not relevant in terms of making the order and are therefore not included.

For completeness and ease of reference for the purposes of this report, the reasons given within the Section 211 notice (23/A0033/TCA) were:

2 Willows- Fell because of close proximity to house, damage to driveway surface, damage to pathway surface near front door of property, potential damage to property (roots and falling), root ingress to drains, likely rot (a recently felled, nearby Willow of similar age had a rotten core, risk of branches falling on parked vehicles, a large 10" diameter branch fell onto the drive some three years ago).

Objection b.

b. Damage to the driveway

Response to objection b.

T1 and T2 of the order are sited close to the edge of the driveway to the property. The driveway is cracked in some locations where there are roots beneath and some of the edging stones have been displaced. Similarly, some cracking is noted on the pedestrian pathway to the front door which is of the same material and level as the drive. Cracking and displacement of driveways and paths is commonly seen where trees are in close proximity. In most instances the cracking or lifting of the surface is not sufficient to make the driveway structurally unfit or difficult to use. It is appreciated that cracking or lifting of the surface can be unsightly and localised repair or re-laying of surfaces can be accomplished where aesthetic improvements are desirable. In certain instances, roots directly beneath the surface of the drive can be damaged by the pressure imposed by vehicles. This can result in scar tissue building up due to repeated damage and defects being exacerbated. In these instances, it is often possible to undertake localised root pruning to remove the damaged root and then repair the drive. In the case of the subject property, the cracking and lifting of the drive noted at the time of the site visit wasn't sufficient to warrant re-surfacing or repair.

Objection c.

c. Raising of the floor level of the garage

Response to objection c

A site visit was carried out on the 5th of July. Concerns had been raised that the floor of the garage was lifting and that the cause was the presence of a root from the Willow trees. A trial pit was excavated down to circa 600mm depth immediately in front of the garage door. The pit was located in line with the area of the floor which was thought to be lifting and making contact with the centre of the bottom of the garage door. Immediately below the concrete surface and down to a depth of approximately 450mm-500mm was lightly consolidated fill/rubble. Only very fine fibrous roots were found. Below this level was brown clay with further fibrous roots and occasional roots of around 10mm diameter. However, there were no roots of a size or in a location capable of causing direct displacement. Direct displacement is the mechanism by which roots or the stem of a tree, displace structures via incremental growth.

Objection d.

d. Concerns regarding the lean of the trees

Response to objection d.

Concerns were raised due to the lean of the trees. Although the trees are leaning, this is generally not a cause for concern if the lean is long established as with the trees in question. Trees exhibit leaning behaviour for a number of reasons, these include: poor support at planting which results in the tree stabilising at an angle, phototropism, where the tree grows towards the sun or lighter part of the plot, previous destabilisation i.e., storm damage where the tree has been partially displaced and then restabilised. It is not clear why the subject trees lean. However, the lean appears to be long established and the trees stable, judging from an examination of their form and therefore this is not determinative in relation to reasons for removal. The contrary position would be if a tree which had previously been growing vertically, was displaced from the vertical. This is usually accompanied by displacement of soil or other surfaces around the base of the tree, and the periphery of the major roots. However, this is not the case with the subject trees.

Objection e

e. Proximity to property

Response to Objection e.

Concerns have been raised regarding the proximity of the trees to the property. The objector's position is that the trees are far too close to the property. Whilst it is understandable that concern may be caused by large trees close to properties, the perception of such trees by occupants varies widely. The authority must balance the views of the tree owners or occupants of a property -where those views are averse to the trees in question- with the responsibility to protect the amenity the trees provide to the area.

Conclusion in response to objections

The objections to the order have been carefully considered and detailed investigation carried out to assess the concerns relating to objection C in particular. However, there was no evidence found which supported the concerns raised in objection C and the points raised in the other objections are not felt to outweigh the amenity value of the trees in question.

- 3.4 Applications can be made and determined under the TPO (if confirmed) and if those applications are refused by Lichfield District Council then the applicant has recourse to appeal to the Planning Inspectorate (PINS).
- 3.5 As per 2.1 and taking the above into account it is recommended that Committee confirm the order with the modifications detailed.

Alternative Options	1. The Committee may choose not to confirm the Tree Preservation Order.
Consultation	 There is a duty to consult the owner of the affected property and all neighbouring properties (who may have common law rights to work on trees protected by the TPO) when the TPO is made. A copy of the order is served on all affected properties and owners/occupiers are invited to comment or object within 28 days of the date of the order.
Financial	1. Tree Preservation Orders make provision for the payment by the Local

	within a twelve month period from the date of their decision, as a direct
	result of their refusal of any consent under the Tree Preservation Order or

	implications in the confirmation of a Preservation Order.

TOWN AND COUNTRY PLANNING ACT 1990

The Lichfield District (Colton and the Ridwares) Tree Preservation Order 2023/00481/TPO

Land at Wyevern, Bellamour Way, Colton

The Lichfield District Council, in exercise of the powers conferred on them by section 198 of the Town and Country Planning Act 1990 make the following Order—

Citation

1. This Order may be cited as the Lichfield District (Colton and the Ridwares) Tree Preservation Order (2023/00481/TPO)

Interpretation

2.— (1) In this Order "the authority" means the Lichfield District Council

(2) In this Order any reference to a numbered section is a reference to the section so numbered in the Town and Country Planning Act 1990 and any reference to a numbered regulation is a reference to the regulation so numbered in the Town and Country Planning (Tree Preservation)(England) Regulations 2012.

Effect

3.— (1) Subject to article 4, this Order takes effect provisionally on the date on which it is made.

(2) Without prejudice to subsection (7) of section 198 (power to make tree preservation orders) or subsection (1) of section 200 (tree preservation orders: Forestry Commissioners) and, subject to the exceptions in regulation 14, no person shall—

- (a) cut down, top, lop, uproot, wilfully damage, or wilfully destroy; or
- (b) cause or permit the cutting down, topping, lopping, uprooting, wilful damage or wilful destruction of,

any tree specified in the Schedule to this Order except with the written consent of the authority in accordance with regulations 16 and 17, or of the Secretary of State in accordance with regulation 23, and, where such consent is given subject to conditions, in accordance with those conditions.

Application to trees to be planted pursuant to a condition

4. In relation to any tree identified in the first column of the Schedule by the letter "C", being a tree to be planted pursuant to a condition imposed under paragraph (a) of section 197 (planning permission to include appropriate provision for preservation and planting of trees), this Order takes effect as from the time when the tree is planted.


