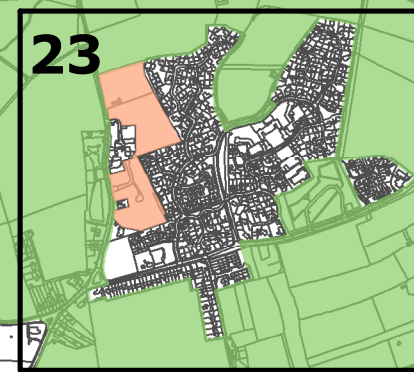


INSET 3 BURNTWOOD

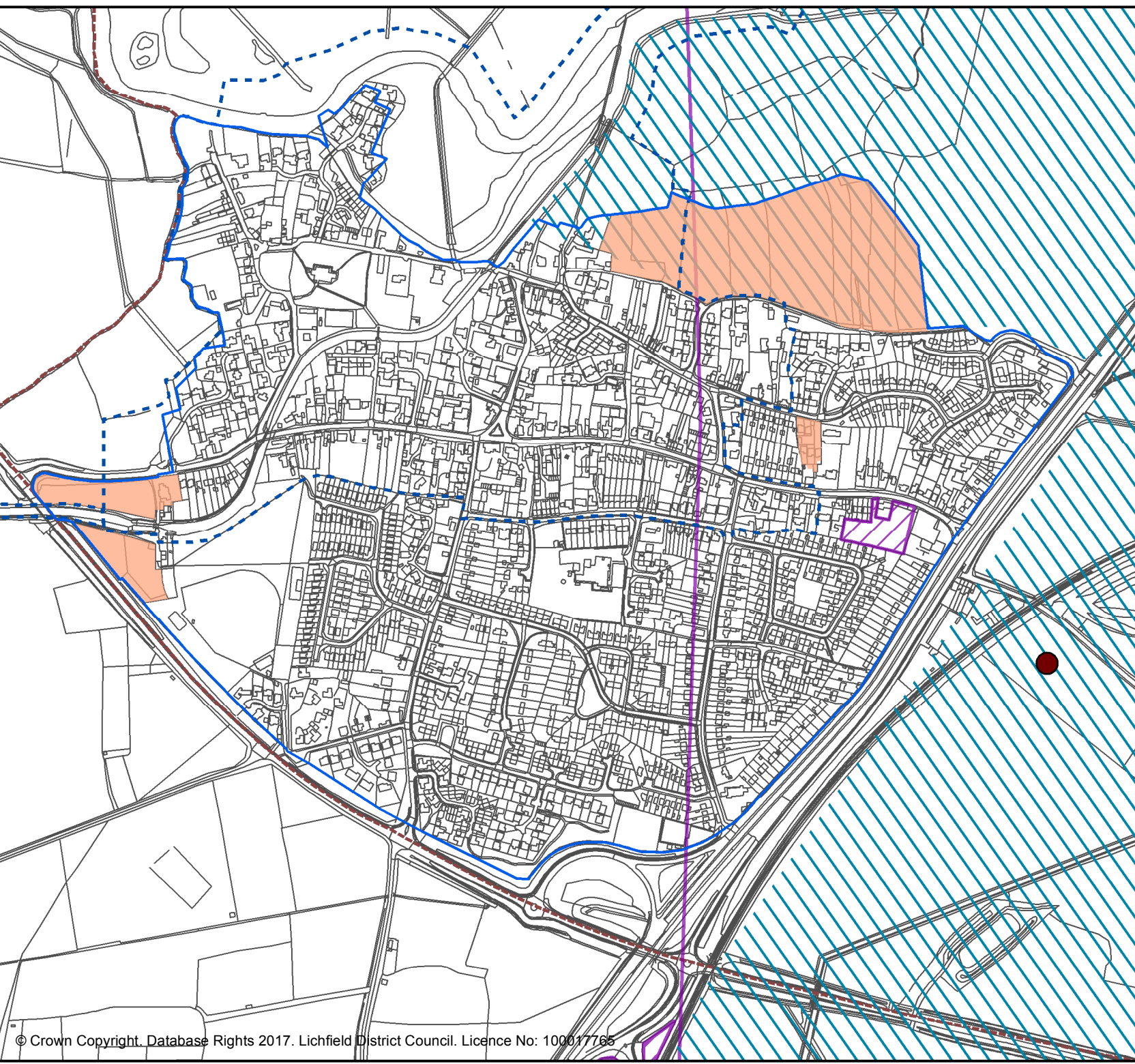

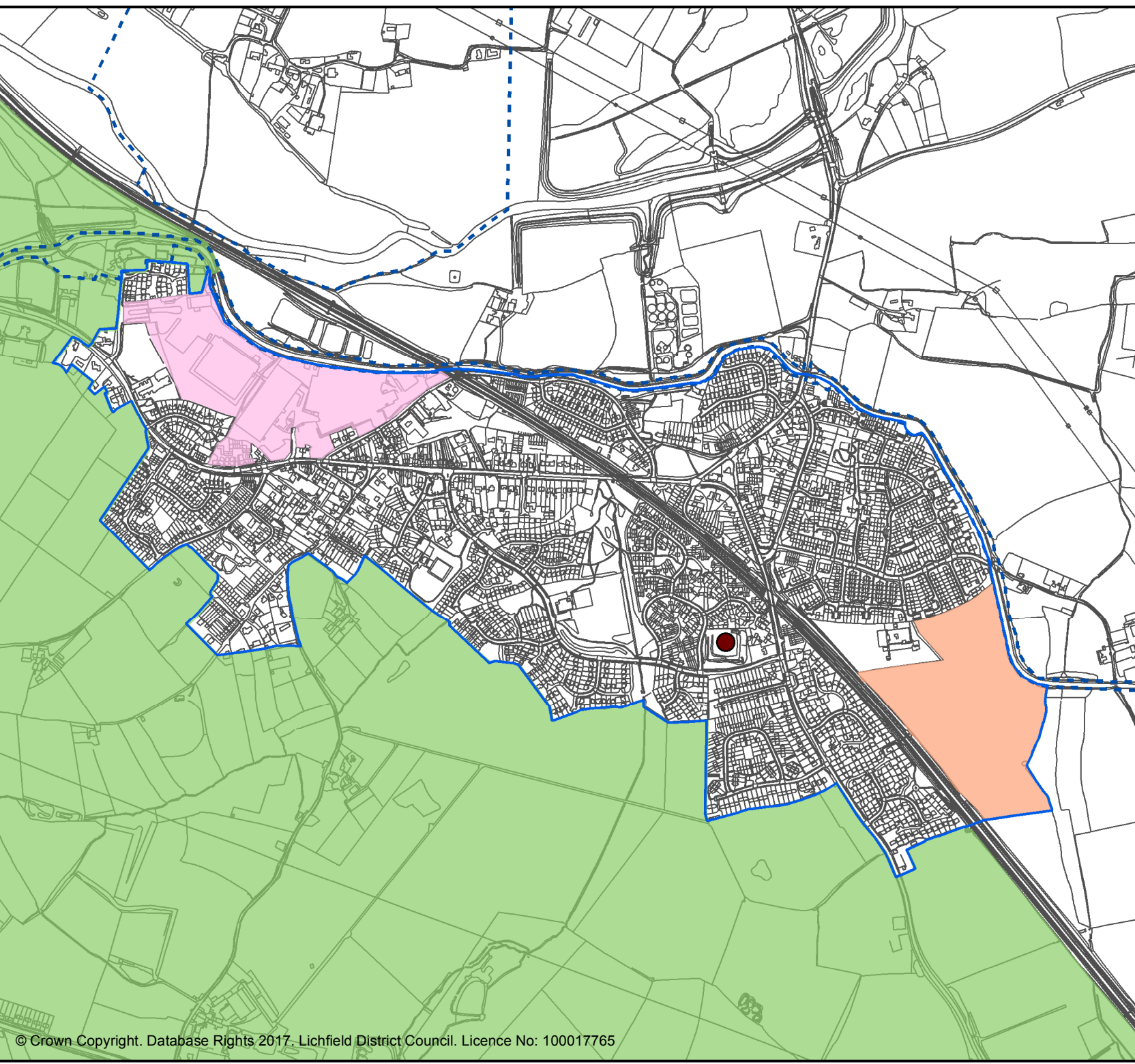


INSET 5 ARMITAGE WITH HANDSACRE

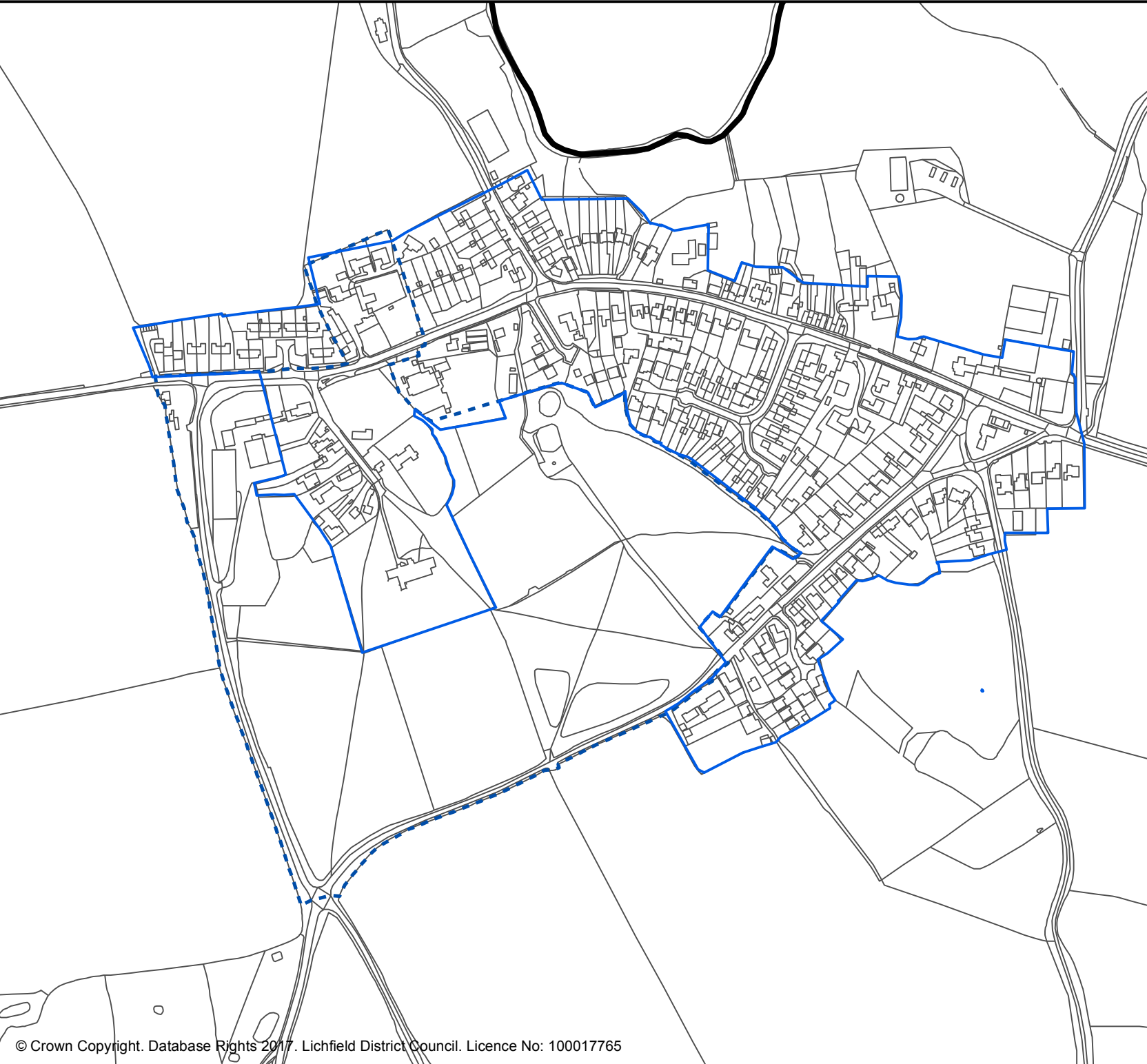


INSET 6 CLIFTON CAMPVILLE



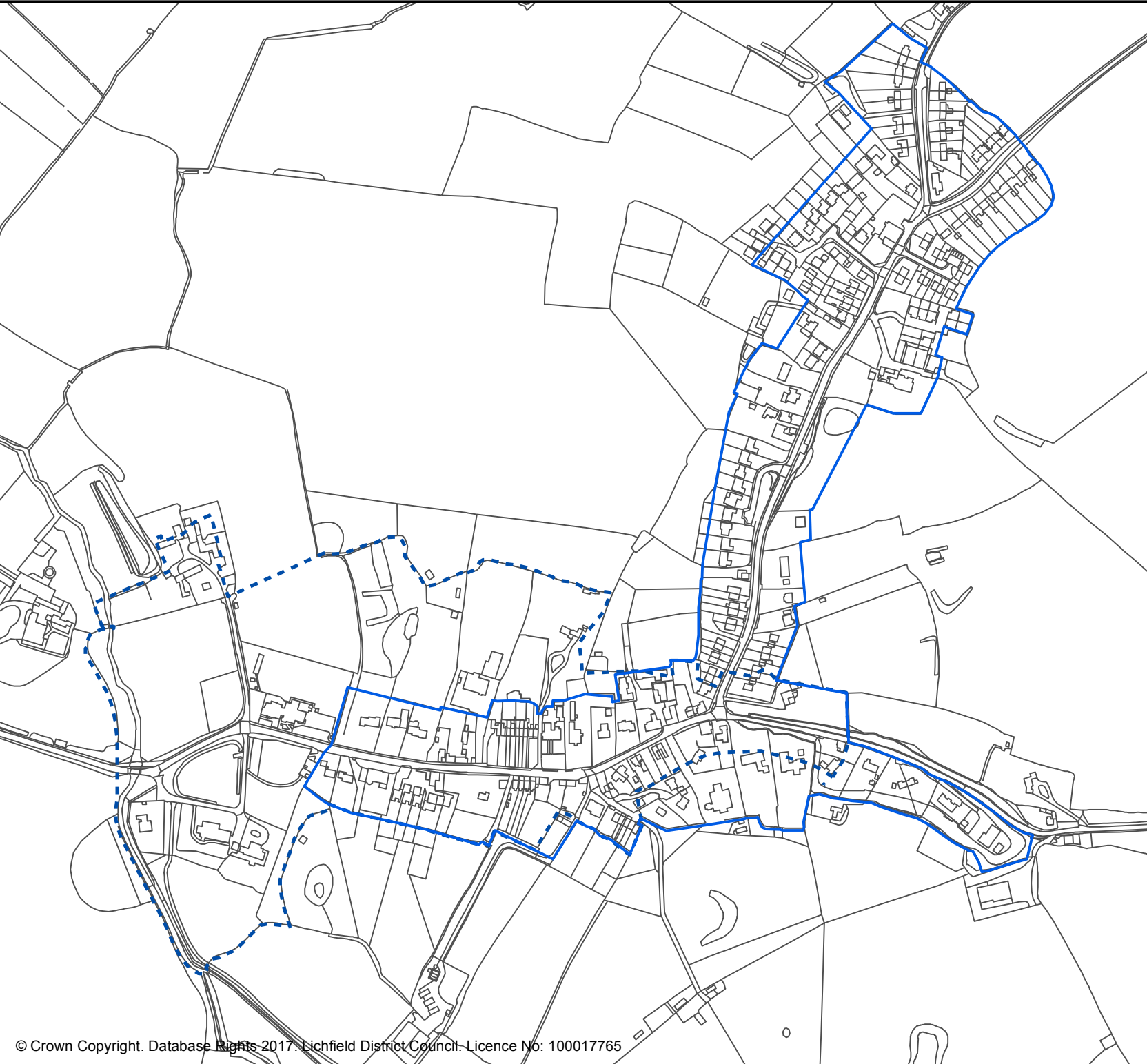


INSET 7 COLTON

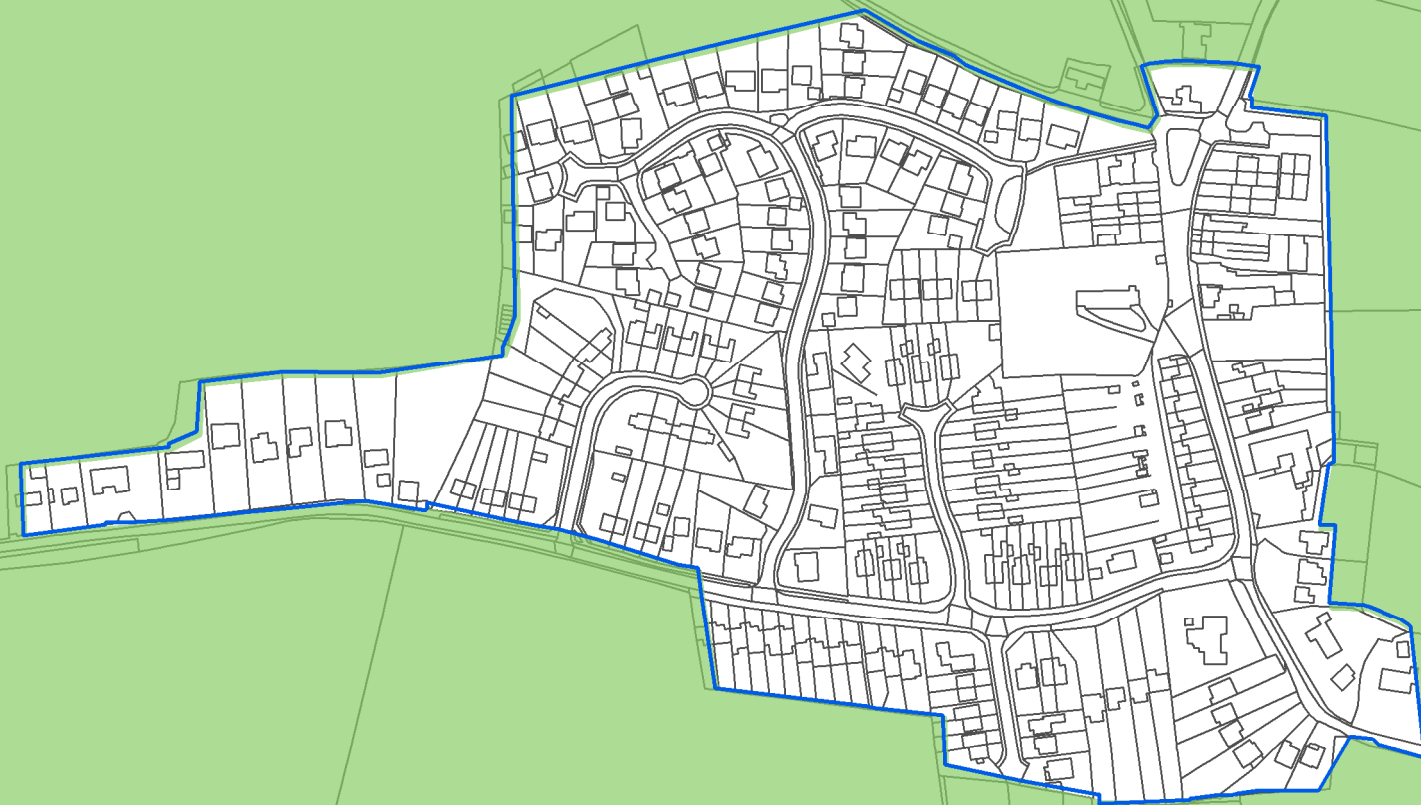

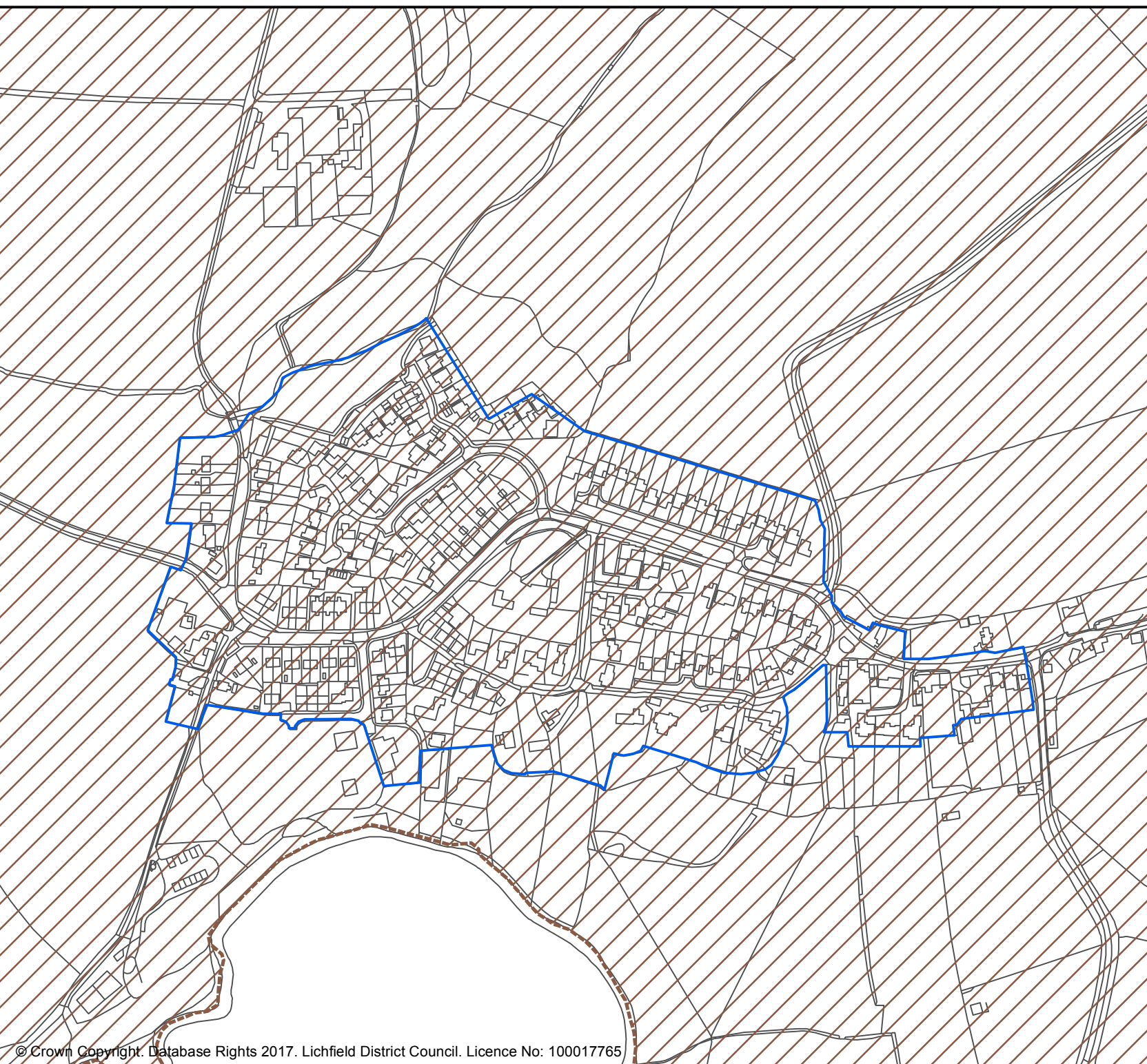


INSET 9 EDINGALE

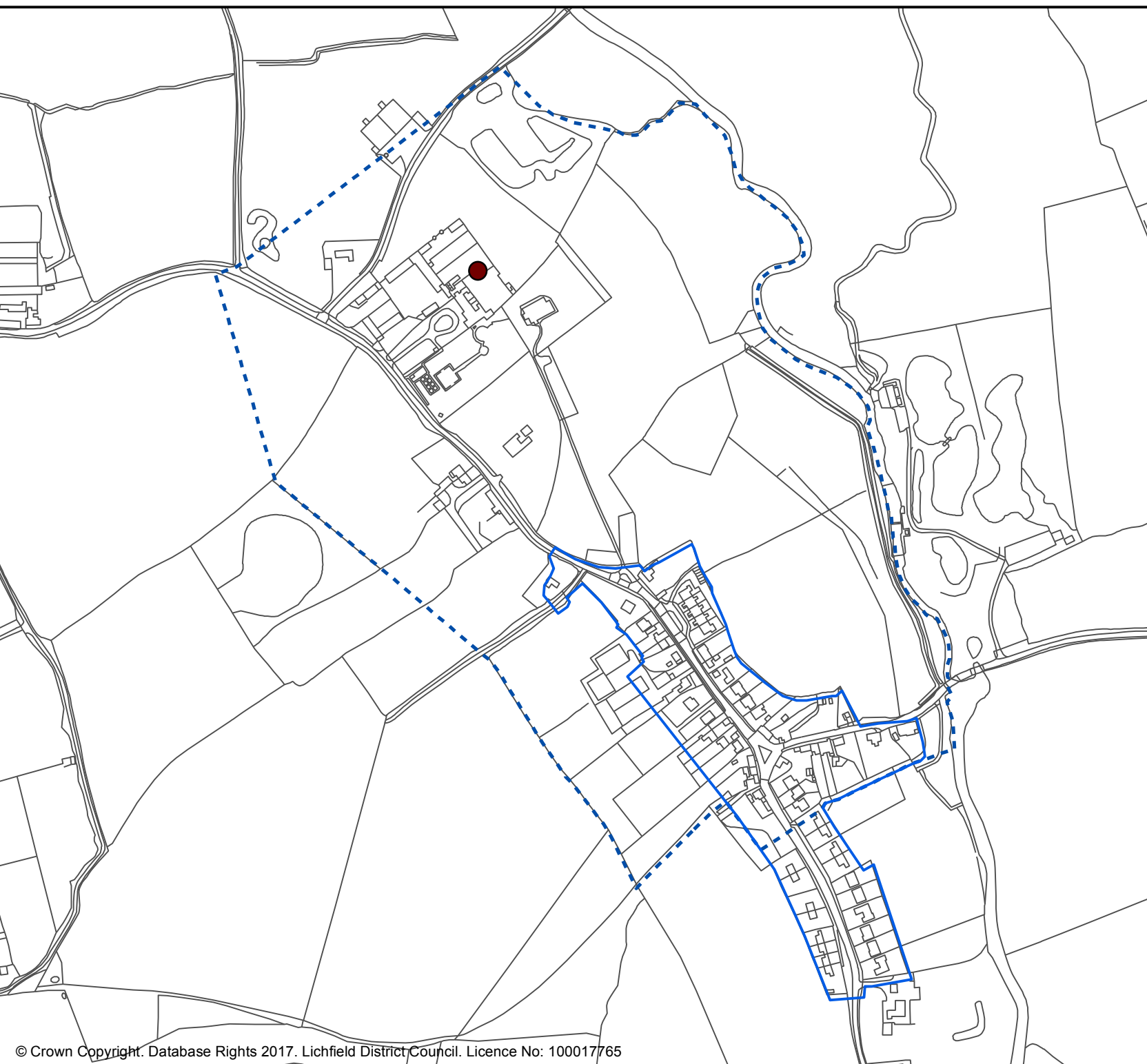


INSET 13 HAMSTALL RIDWARE

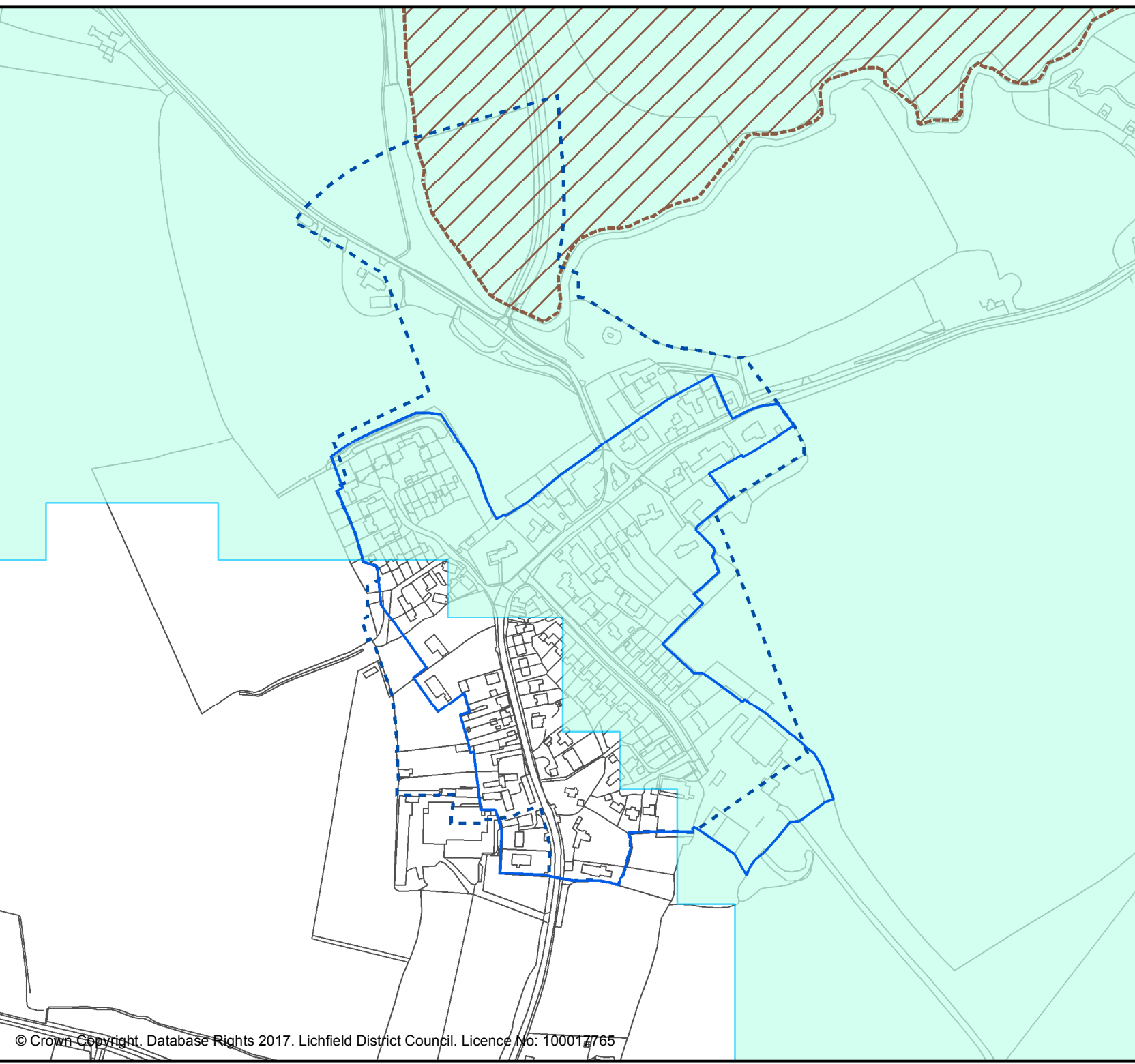

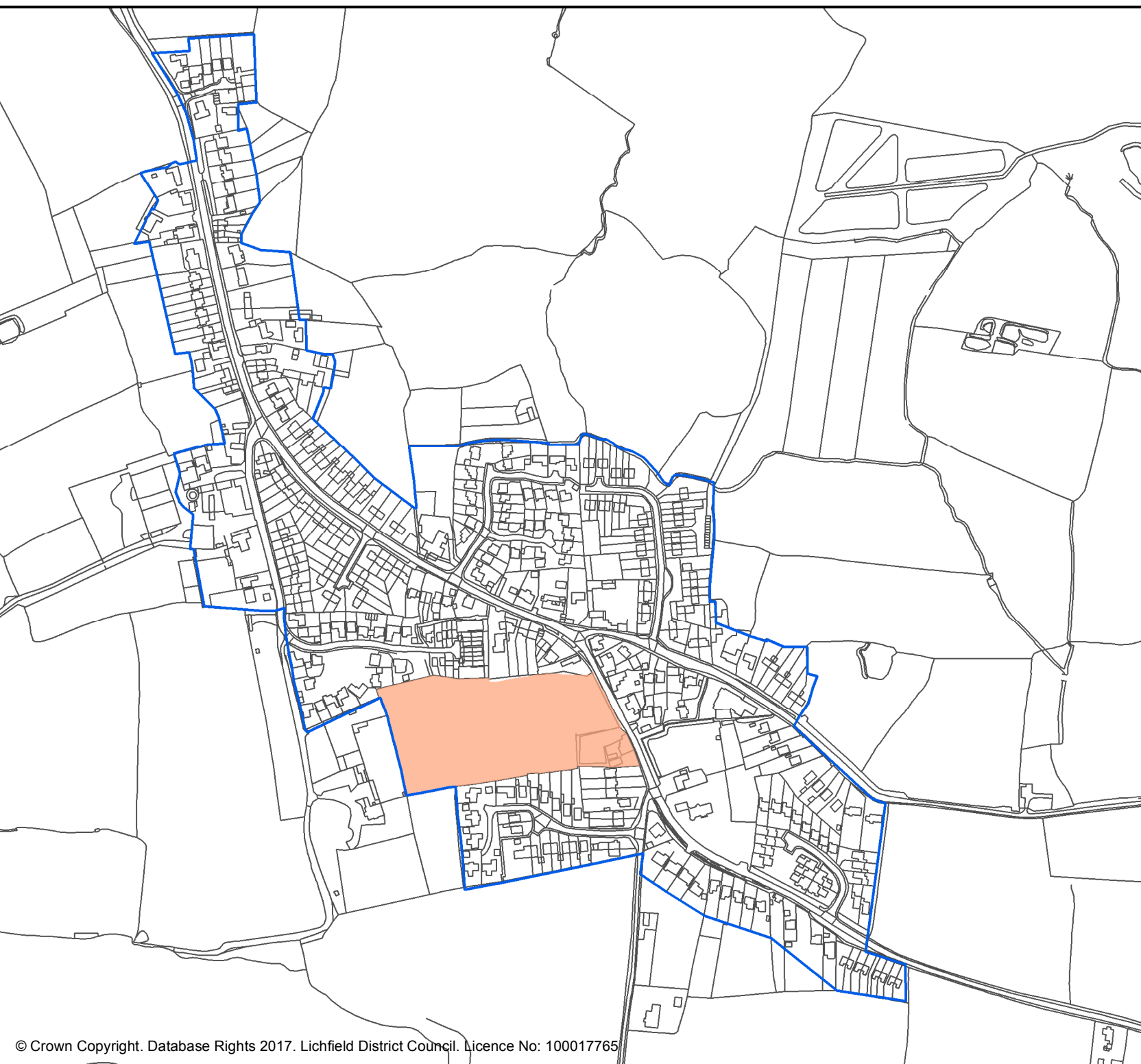


INSET 15 HILL RIDWARE

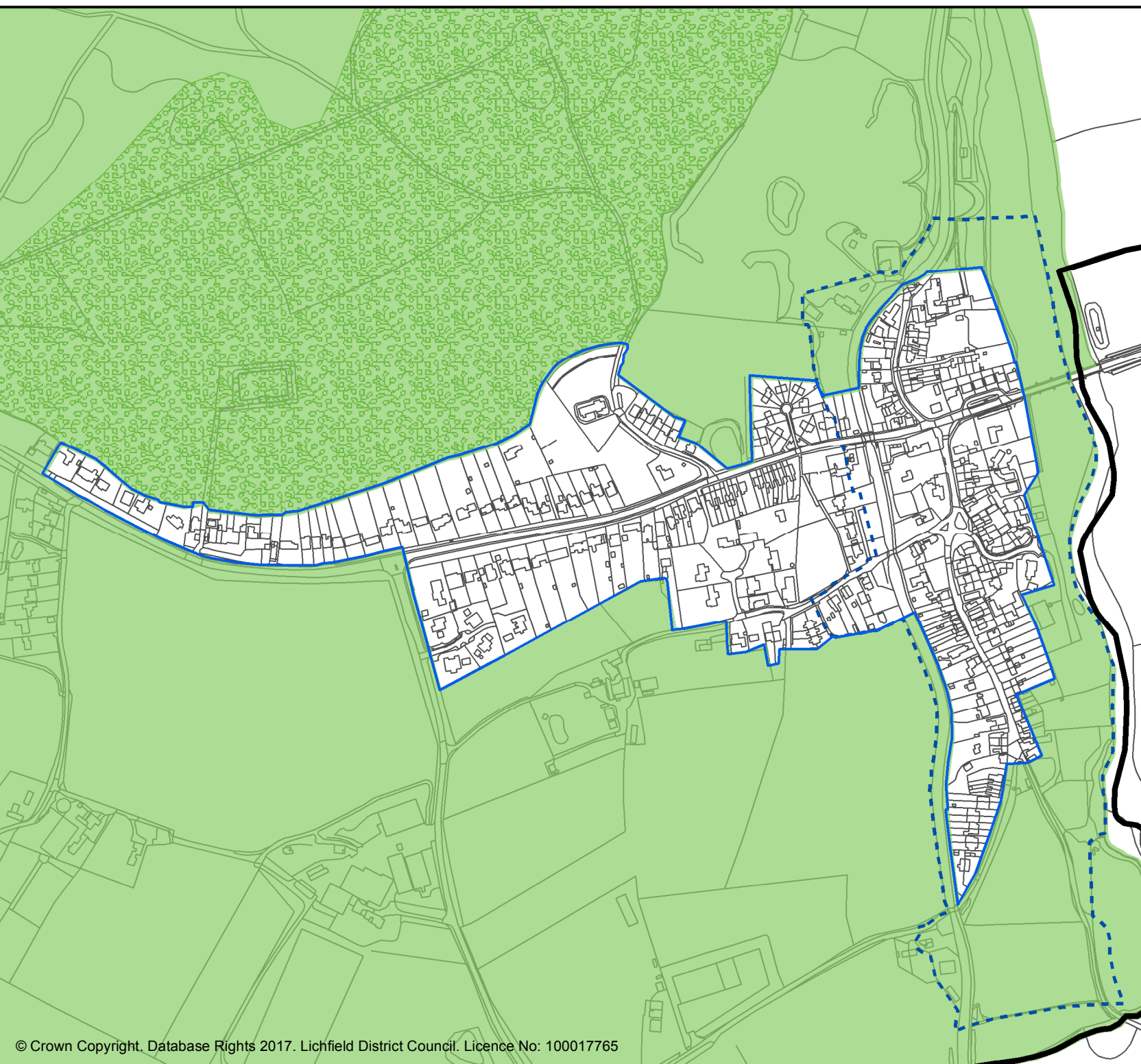

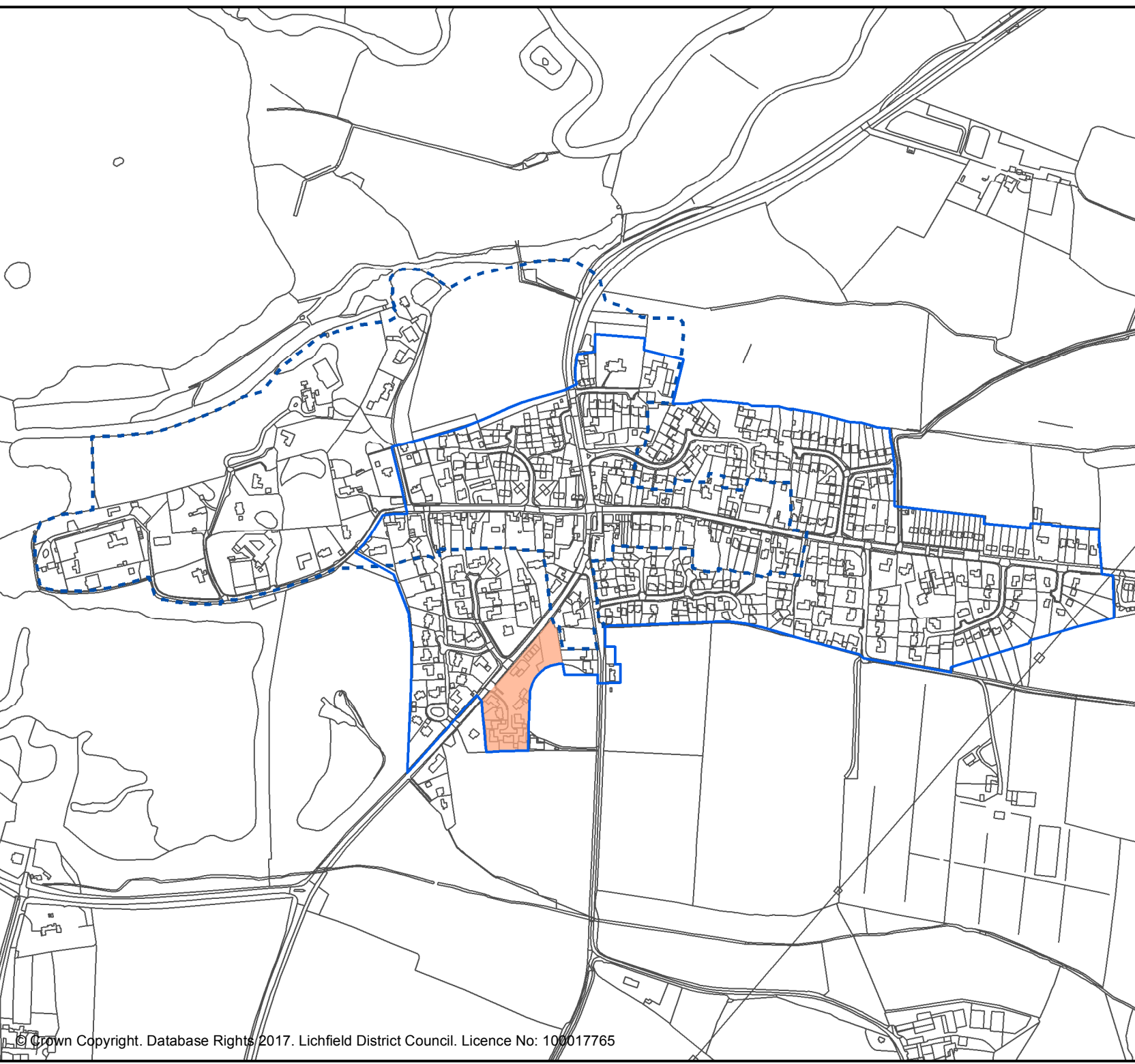


INSET 17 KINGS BROMLEY

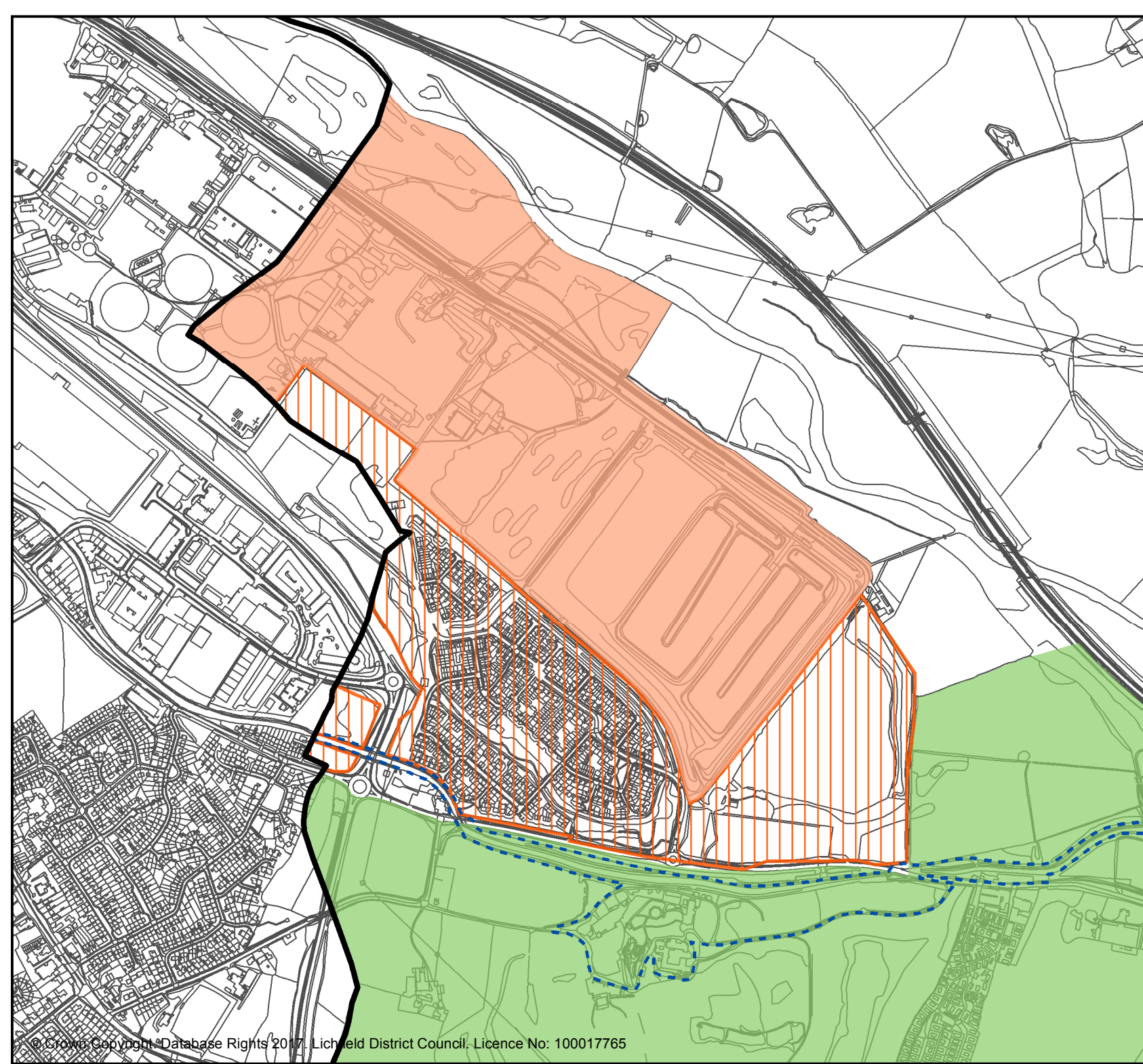


INSET 18 EAST OF RUGELEY

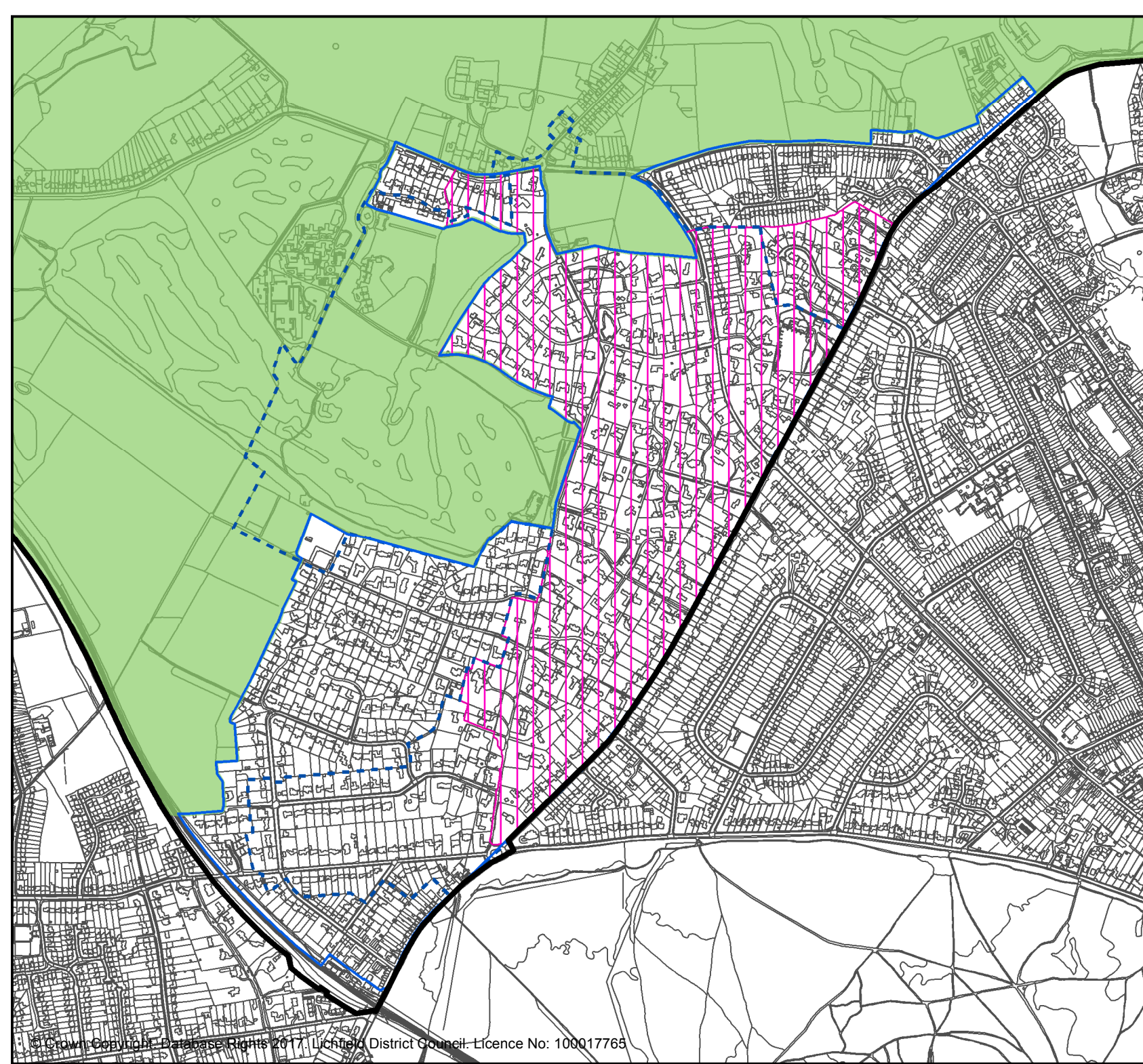

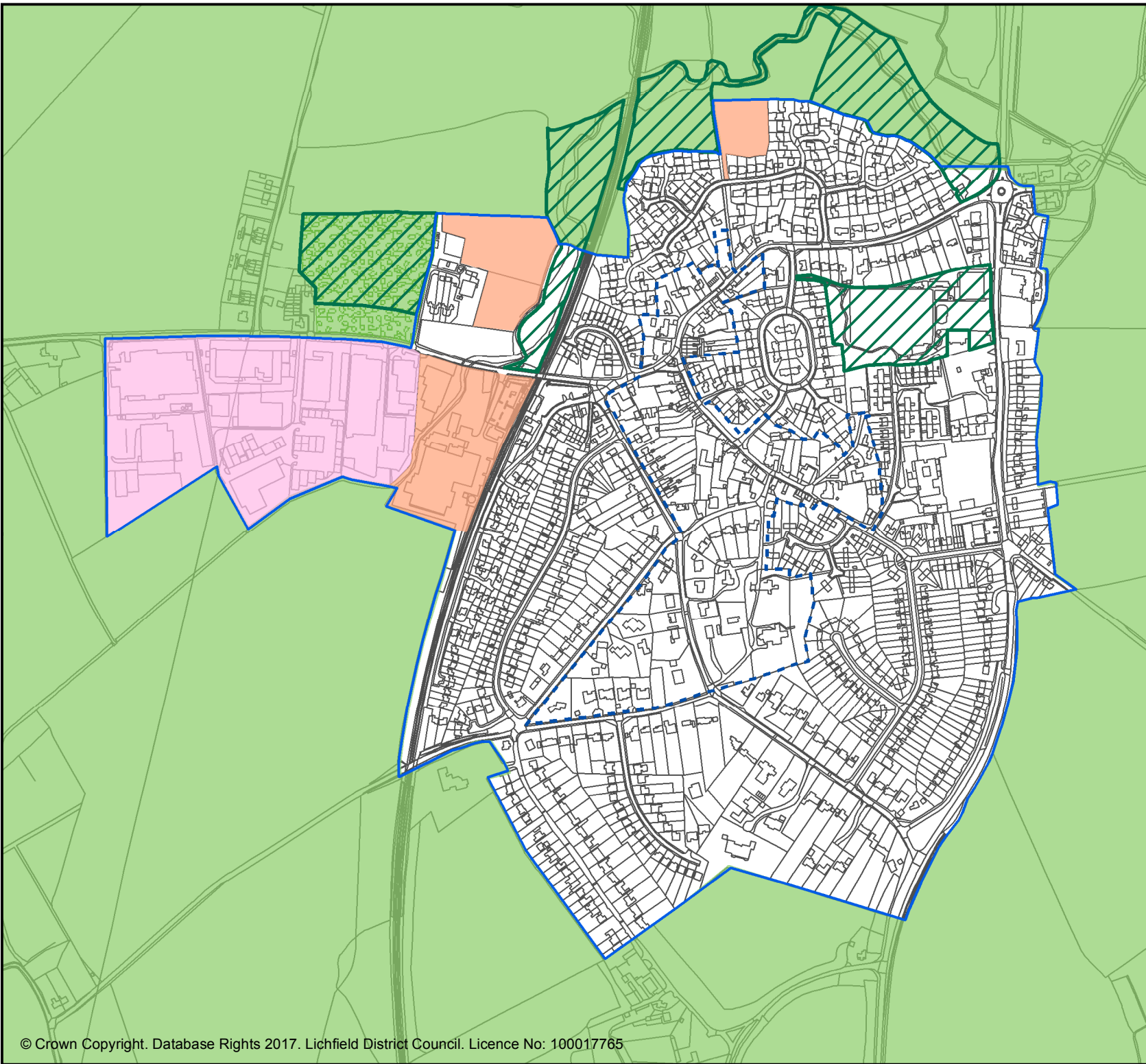


INSET 22 SHENSTONE

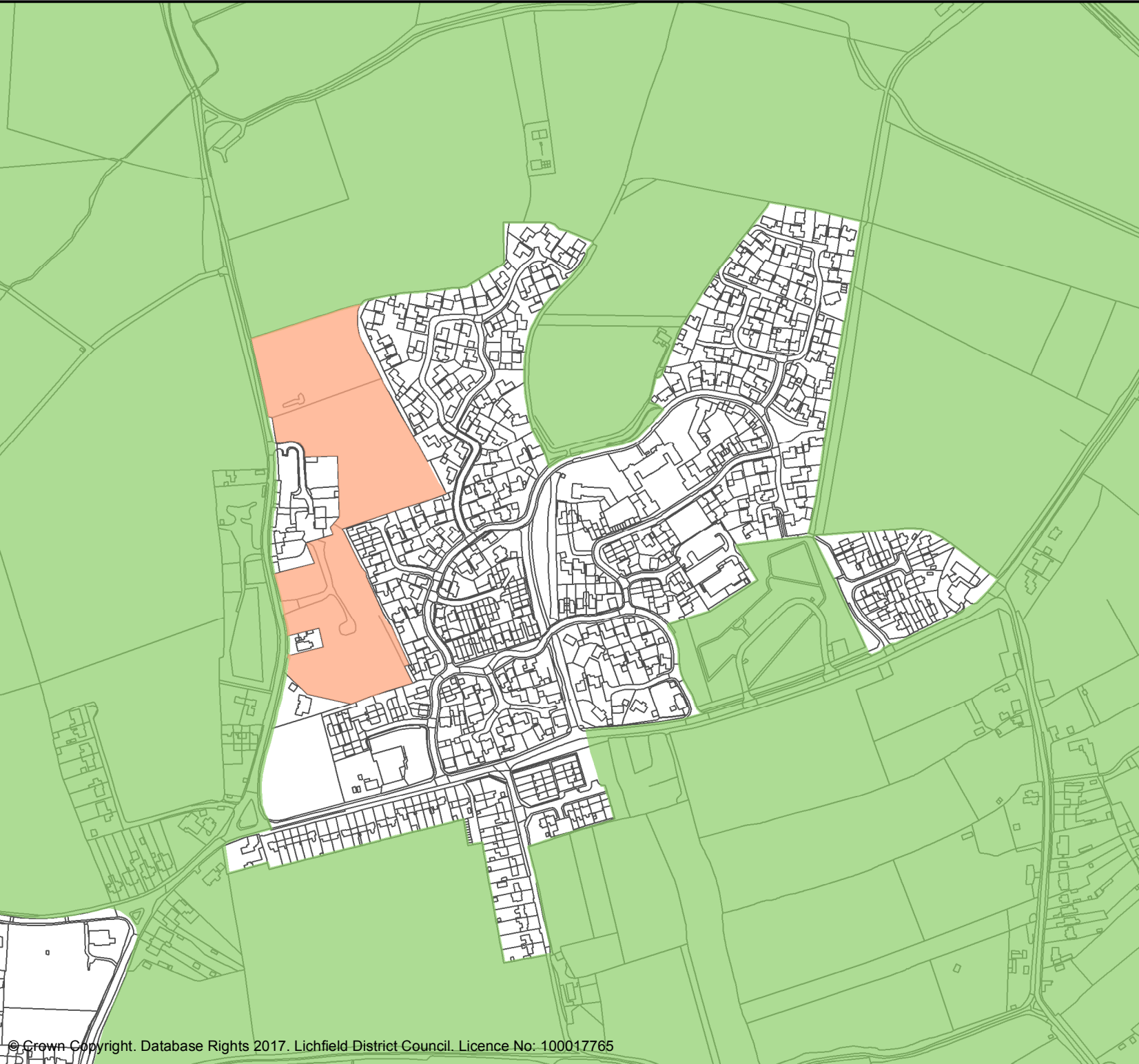


INSET 23 ST MATTHEWS

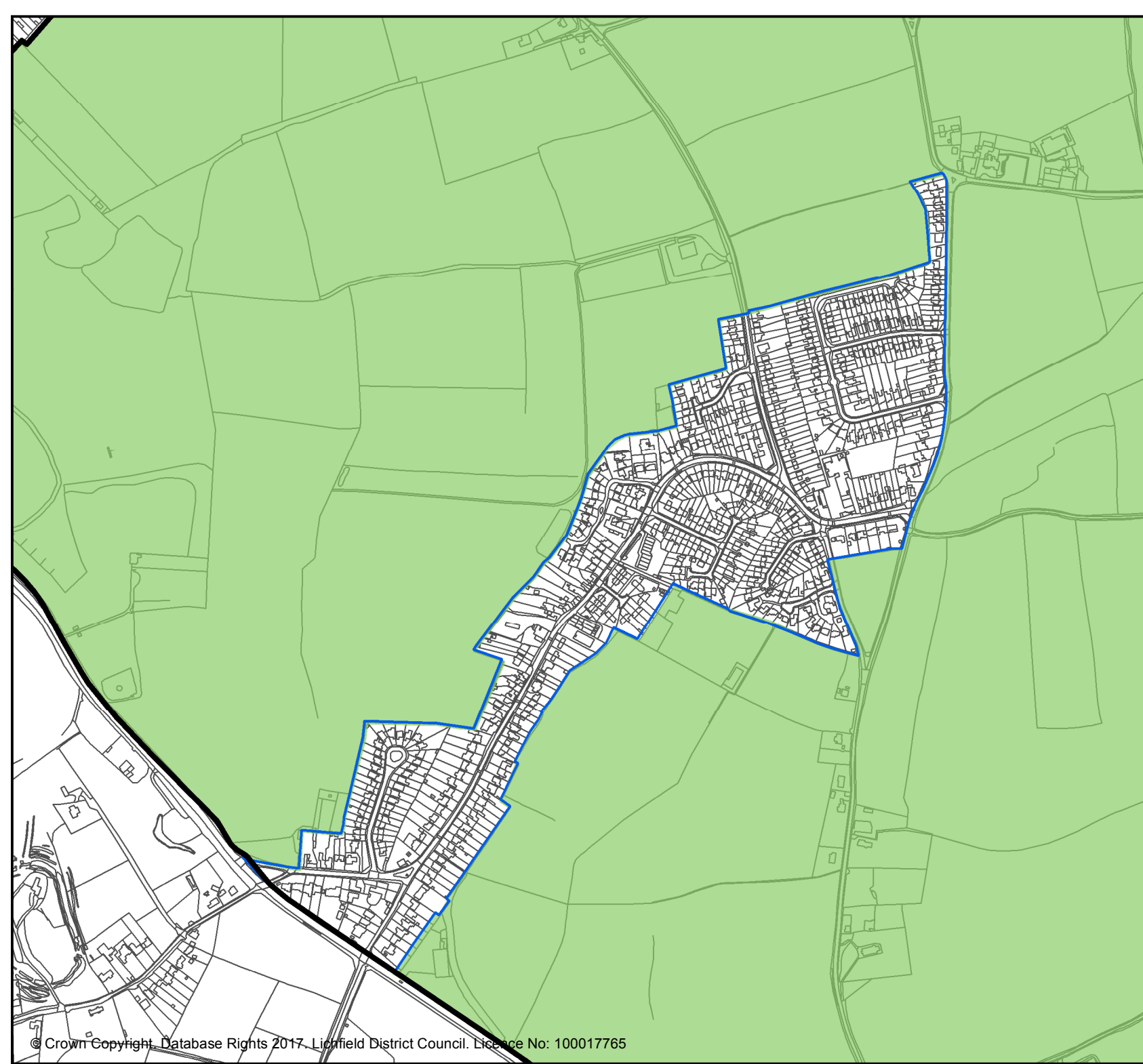


INSET 24 STONNALL

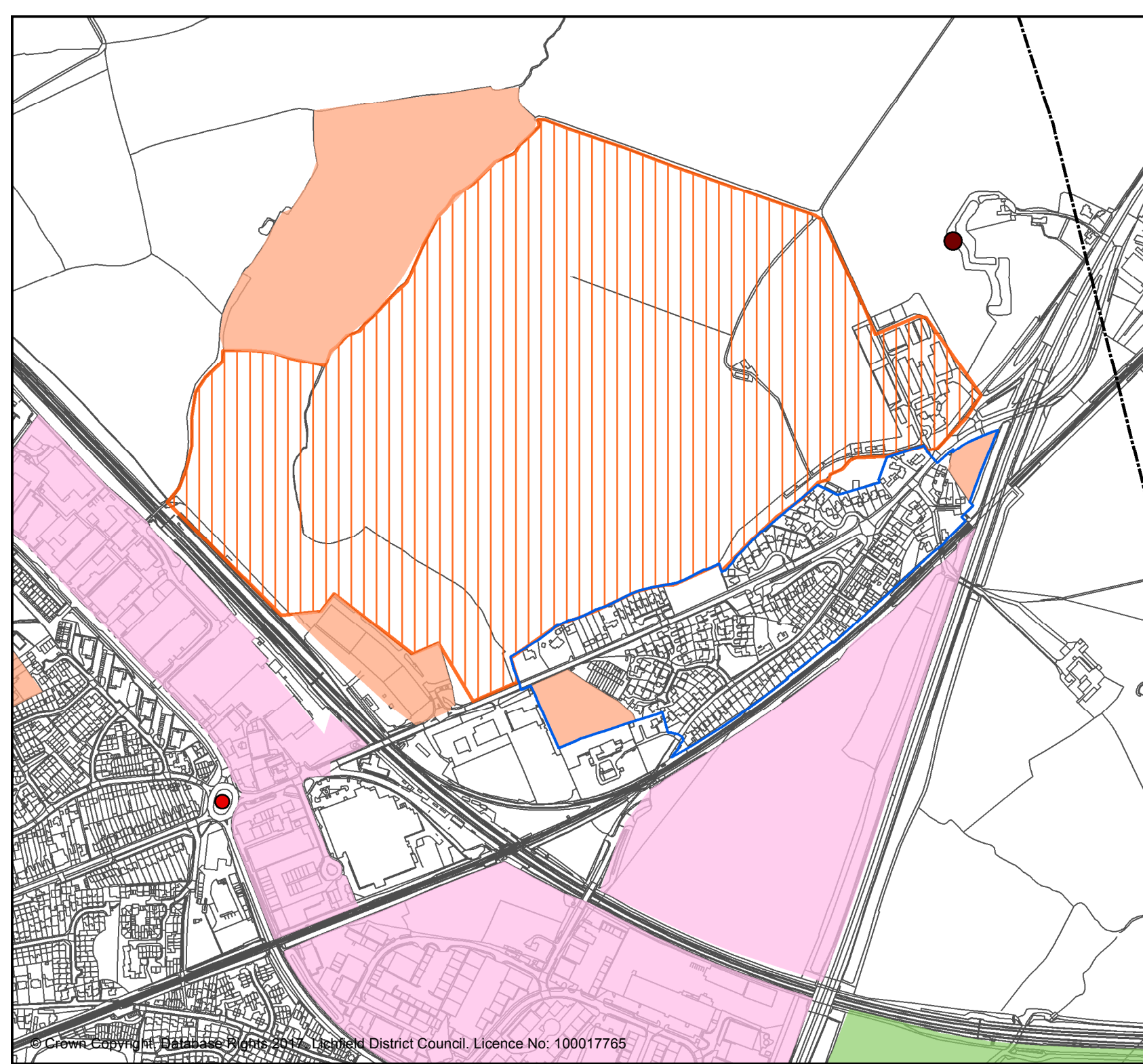

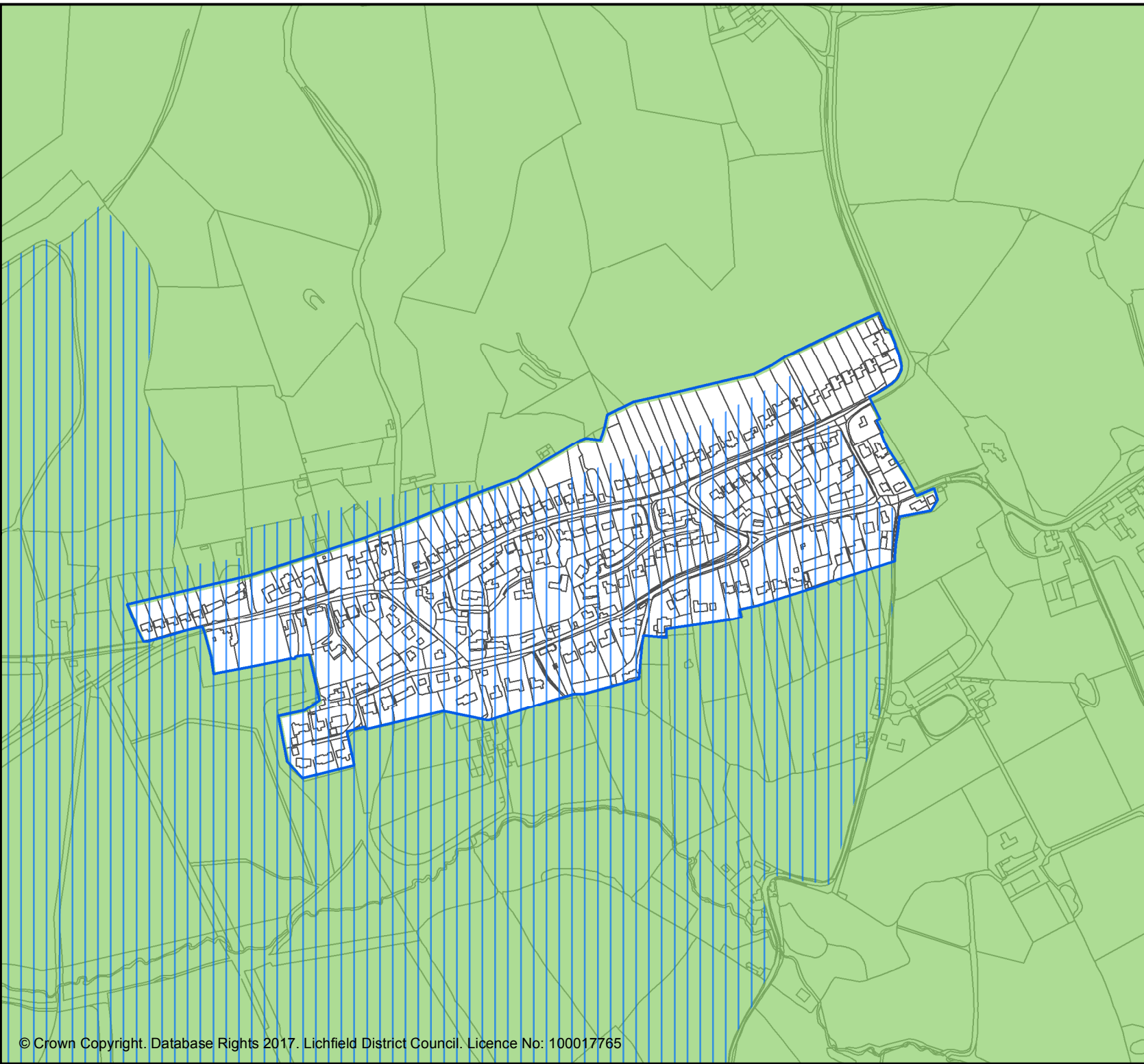


INSET 26 UPPER LONGDON

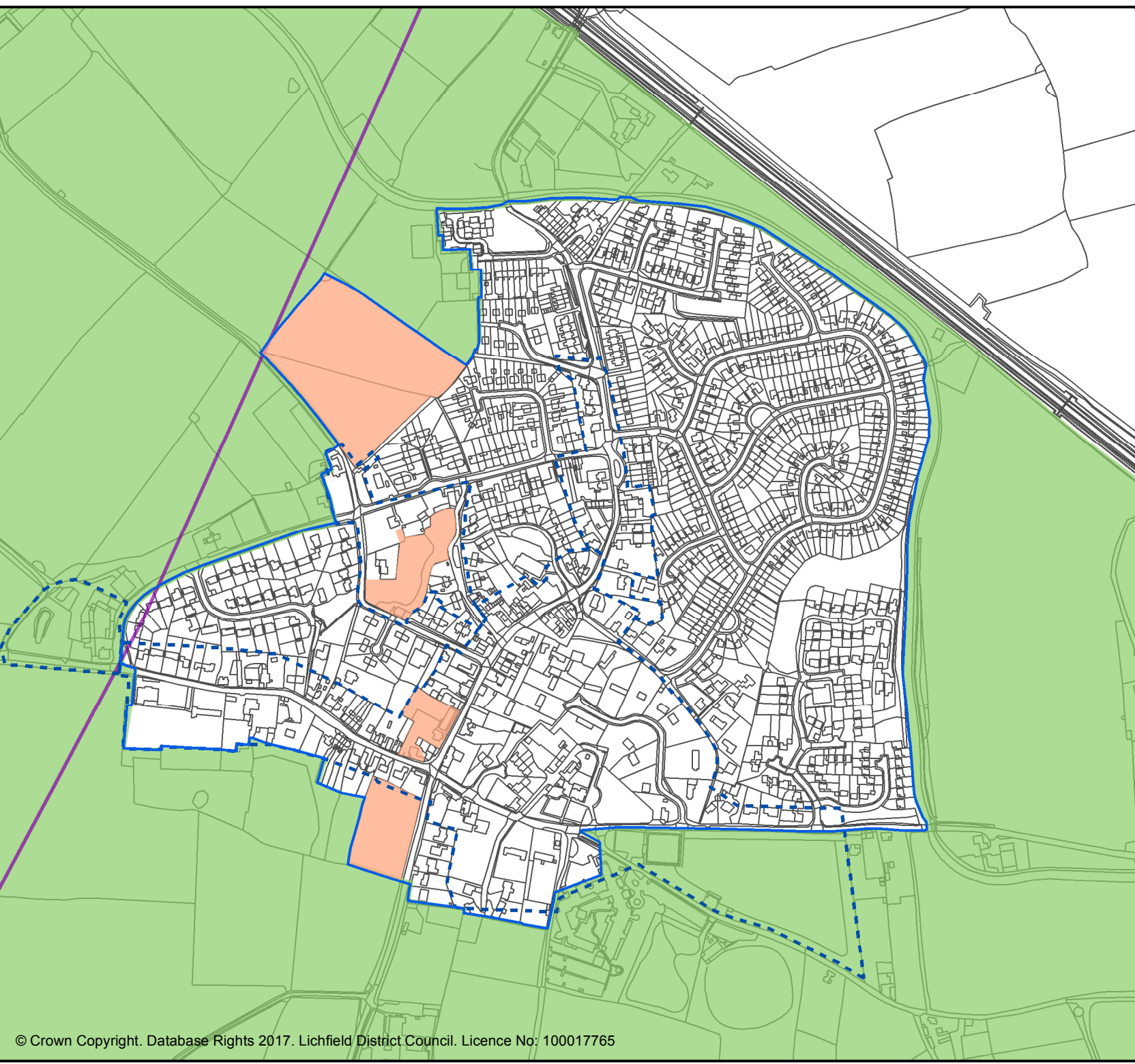
